

Revised Order

Whereas, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

2. And whereas, the Shree H.H.Patel College of Education for Women's, Shreyas Vidhyalaya Campus Ashanagar Part-2, B/H, Harinagar-2 Udhna District- Surat-394210 Gujarat by affidavit dt. 01.01.2015 has consented to come under new Regulations and sought for two basic units in B.Ed, which require additional facilities

3. And whereas, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely,

i. The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.

ii. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.

iii. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.

iv. In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted along with the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institutions shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Western Regional Committee in respect of Section 17/complaint cases etc.

4. Now therefore, in the light of the above and in accordance with the NCTE Regulations, 2014, the Western Regional Committee (NCTE) hereby issues the revised recognition order to Shree H.H.Patel College of Education for Women's, Shreyas Vidhyalaya Campus Ashanagar Part-2, B/H, Harinagar-2 Udhna District- Surat-394210 Gujarat for conducting B.Ed, programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16 subject to fulfillment of the conditions mentioned herein before 31.10.2015.

5. Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.


6. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.


7. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:

- a) Sanctioned programmes along with annual intake in the institution;
- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph;
- c) Name of faculty members who left or joined during the last quarter;
- d) Names of Students admitted during the current session, along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e) Fee charged from students;
- f) Available infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to and additions, if any in the last quarter;
- i) The affidavit with enclosure submitted along with application;
- j) The institution shall be free to post additional relevant information, if it so desires;
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act, 1995.

8. Recognition order no. WRC/2-32/75/323202/2005/6342 dt. 09.06.2005 & WRC/AP/W/01293/323202/154th /2011/82901-82955 dt. 17.11.2011 be treated as cancelled from the date of issue of this revised order.





WHEREAS Recognition/Permission was granted to the institute SHREE H.H. PATEL COLLEGE OF EDUCATION FOR WOMEN, SHREYAS VIDHYALAYA CAMPUS ASHANAGAR PART-2, B/H HARINAGAR-2, UDHNA SURAT 394210 GUJARAT under section 14 of NCTE Act, 1993 for conducting B.ED course with an intake of 100 from the academic session 2005-2006; vide order No. WRC/232/76/323202/2005/6342 dated 09.08.2005.

2. WHEREAS on the direction of the NCTE headquarters vide do letter No. 49-8/2008/NCTE (N & S) /78627 dated 21.05.2008 from NCTE, New Delhi directing WRC to conduct the inspection of 129 colleges & Gujarat u/s 17 of the NCTE Act 1993, as per the observation of Prin. A.U.Patel, the Chairman, fee/Admission Committee for self Finance B.ED/B.P.ED. course, Gujarat State & Formal Vice-Chancellor, Gujarat University The Western Regional Committee had constituted a Visiting Team u/s 17 of NCTE Act, 1993 to Visit the institution.

3. AND WHEREAS, THE inspection of the institution was conducted on 06.06.2008

4. AND WHEREAS, the matter was considered by the WRC in its 104th meeting of WRC hereby committee noted that the following deficiencies exist vis-à-vis NCTE norms:-

1. Built-up area is inadequate for PTC, B.Ed. courses.
2. Size of classrooms inadequate.
3. Salary to teachers are not paid through bank.
4. Number of books in library are less.

5. AND WHEREAS the WRC directed that an opportunity be given the institution to make a representation within 30 days from the date of the letter before withdrawal of recognition as per proviso contained under Section 17 of the NCTE Act on account of deficiencies as mentioned above and therefore, a cause notice was issued to the institution on 03.08.2008.

5. AND WHEREAS the matter was again considered by the Committee in its 110th meeting held November 12-14, 2008 and having taken into consideration all the relevant facts of the case, it was decided withdrawn recognition for conducting B.ED course from the academic session 2009-2010.

6. Now, therefore recognition to SHREE H.H. PATEL COLLEGE OF EDUCATION FOR WOMEN SHREYAS VIDHYALAYA CAMPUS ASHANAGAR PART-2, B/H. HARINAGAR-2, UDHNA SURAT 394210 GUJARAT in terms of section 17(i) of the NCTE Act, 1993 is hereby withdrawn from academic session 2009-2010 on the following grounds.

7. Affiliating Body/ State Govt. are advised not to admit/ allot any student in B.ED in the said institute. In accordance to the section 17(4) of NCTE Act, 1993, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposes of employment under the Center Government, any State Government or University, or in any school, college or other educational body aided by the Central Government or any State Government.

8. Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1- Bahadur Shah Zafar Marg, Near RTO, New Delhi-110002 against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines of appeal are enclosed herewith.
