Recognition Order

WHEREAS in terms of Section 14(1)/Section 15(1) of the NCTE Act, 1993 THE COLLEGE OF SHREE SWAMINARAYAN B.ED. COLLEGE, SHREE SHAHJANAND EDUCATION TRUST, AT. & TA. VIJAPUR, DIST. MEHSANA-382875, GUJARAT has submitted an application (Code No.- APW04330/323430) to the Western Regional Committee of NCTE for grant of recognition/permission for conducting B.ED(CO.ED) course with an annual intake of 100 students on 27-12-2006 .

2. AND WHEREAS on scrutiny/perusal of the application submitted by the institution, the documents attached therewith , the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the SEC teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) /15(3)(a) of the NCTE Act, 1993, the Western Regional Committee hereby grants recognition / permission to THE COLLEGE OF SHREE SWAMINARAYAN B.ED. COLLEGE, SHREE SHAHJANAND EDUCATION TRUST, AT. & TA. VIJAPUR, DIST. MEHSANA-382875, GUJARAT for conducting B.ED(CO.ED) course of SEC of 1 year duration with an annual intake of 100(SEC) under clause 7(11) of NCTE(Recognition Norms & Procedure) Regulation 2007 subject to fulfillment of the following conditions :-

- The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund account into a joint account to be operated along with an officer of the Western Regional Committee.
- The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2007.
- The institution shall ensure that the required number of academic staff for conducting the course is always in position.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable.

5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.


6. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always following as mandatory disclosure:

- (i) Copy of the Application Form
- (ii) Land and Building Particulars.
- (iii) Staff Profile.
- (iv) Recognition letter.
- (v) Information for having fulfilled the norms & standard and other required conditions.

7. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

8. Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, Hans Bhawan, Wing-II, 1, Bahadur Shah Zafar Marg, Near ITO, New Delhi- 110002 against this order under section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. 

Whereas recognition was granted to the institute **SHREE SWAMINARAYAN EDUCATION COLLEGE VIJAPUR, SHREE SAHJANAND EDU.TRUST/F2/20/21 PARTH COMPLEX NR. T.B. HOSPITAL VIJAPUR, MEHSANA, GUJARAT** under section 14 of NCTE Act, 1993 for conducting B.Ed. course with an intake of 100 from the academic session 2008-2009; vide order No.WRC/5-6/102ND/2008/30783-30788 dated 17.03.2008.

2. Whereas on the basis of complaint received against institution, the Western Regional Committee had constituted a visiting team u/s 17 of NCTE Act, 1993 to visit the institution.

3. And whereas, the matter was considered by the WRC in its 120TH meeting of WRC hereby the committee noted that the following deficiencies exist vis-à-vis NCTE norms:-

1. The two replies were received from the institution (1) Ref. No. 61/2009/10 dt. 1.6.2009 regarding selection of Principal and (2) Ref. No. 60/2009/10 dt. 1.6.2009 regarding purchase of land.
2. On scrutiny of the two letters it is resolved that show cause notice be issued to the institution in respect of the validity of the land documents i.e., the institution does not own the land.

4. And whereas, the WRC directed that an opportunity be given the institution to make a written representation within 30 days from the date of the letter before withdrawal of recognition as per provisions contained under Section 17 of the NCTE Act on account of deficiencies as mentioned above and therefore, a show cause notice was issued to the institution on 04.07.2009.

5. And whereas, the matter was again considered by the Committee in its 127TH meeting held on October 14-15, 2009 and having taken into consideration all the relevant facts of the case, it was decided to withdraw recognition for conducting B.Ed. course.

6. Now, therefore recognition to **SHREE SWAMINARAYAN EDUCATION COLLEGE VIJAPUR, SHREE SAHJANAND EDU.TRUST/F2/20/21 PARTH COMPLEX NR. T.B. HOSPITAL VIJAPUR, MEHSANA, GUJARAT** in terms of section 17(1) of the NCTE Act, 1993 is hereby withdrawn from the end of the academic session next to the following date of this withdrawal order on the following grounds.

1. Land documents not valid as per the NCTE norms.

7. Affiliating Body/ State Govt. are advises not to admit/ allot any student in B.Ed. in the said institute. In accordance to the section 17(4) of NCTE Act, 1993, the qualification in teacher education obtained pursuant to such course or training or after undertaking a course or training in such institution, shall not be treated as a valid qualification for purposed of employment under the Center Government, any State Government or University, or in ant school, college or other educational body aided by the Central Government or any State Government.


