RECOGNITION ORDER

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993, Rajiv Gandhi D.Ed. College, Survey no. 503 Mauza Chanda, Tehsil + Distt- Chandrapur- 442401 Maharashtra. (APW05356/1221457) had submitted on 09.01.2007 the application to the Western Regional Committee of the NCTE for grant of recognition for starting the D.Ed. (M) (Co.Ed) Course with an annual intake of 50.

- AND WHEREAS, the inspection of the institution was conducted on 11/2/2008. The matter was considered by WRC in its 110th meeting held on 12th to 14th November 2008 and the Committee decided that " No further process as per decision taken by WRC under agenda item 110.06". Accordingly closure order was issued on 23/4/2009.
- 3. AND WHEREAS, the institution had submitted representation dated 14/8/2009 which was placed in WRC in its 124th meeting held on 20^{th t} to 21st August, 2009 and the Committee decided to seek clarification from the institution on the following point before further processing of the file: Whether the proposed D.Ed. Course is meant for the Linguistic Minority (Muslim

Community) of Maharashtra to be taught through Urdu Language.

- AND WHEREAS, clarification letter was issued to the institution on 28/8/2009. The institution had submitted reply dated 26/8/2009 which was placed before WRC in its 127th meeting held on 14-15 October. 2009 and the Committee deferred the matter for seeking clarification from the NCTE Headquarters. Accordingly, letter was issued to NCTE Headquarters on 5/11/2009.
- AND WHEREAS, reply dated 20/11/2009 received from the NCTE Headquarters was placed in WRC in its 129th meeting and the Committee decided to grant recognition under clause 7(9) of NCTE Regulations 2007. Accordingly letter was issued on 5/1/2010. The institution had submitted reply dated 18/1/2010 which was placed before WRC in its 131st meeting and the Committee decided that clarification be sought from the institution on the following points:

Staff be appointed as per the NCTE Regulations, 2009.

AND WHEREAS, letter was issued on 6/3/2010. The institution had submitted reply dated 27/5/2010 which was placed before WRC in its 134th meeting and the Committee recognition be refused on the following points:

Staff not appointed as per the NCTE norms.

- AND WHEREAS, refusal order was issued on 18/5/2010. The institution filed W.P. No. 3228/2010 in the High Court of Judicature at Bombay, Nagpur Bench, Nagpur. The Hon'ble High Court passed order dated 13/9/2010 , the operative part of the order is as under "Mr. C.S. Kaptan, Advocate for the respondent states that if the petitioner makes a representation against the impugned order dated 14/5/2010/18.5.2010 to the NCTE , Bhopal (respondent herein) along with supporting documents , the Council will consider those documents and make a fresh order in accordance with law. The statement is accepted. The petitioner shall make a representation , as mentioned above, within a period of two weeks from today. The Council shall pass a speaking order on the said representation in accordance with law thereafter within a period of six weeks from the date of receiving the representation. With these observations and directions, the petition is disposed of" . The matter was placed before WRC in its 144th meeting and the Committee decided to issue the letter of intent prior to recognition under clause 7(9) of NCTE Regulations, 2009.
- AND WHEREAS, letter was issued on 16/2/2011. The institution had submitted reply dated 7/4/2011 was placed in WRC in its 150th meeting and the Committee decided that Show cause notice be issued to the institution on the following points: FDRs of Rs. Five lacs and of Rs. Three lacs for Endowment Fund and Reserve Fund

respectively not submitted into joint accounts.

- 9. AND WHEREAS, show cause notice was issued on 21/5/2011. The institution had submitted reply dated 2/7/2011 which was placed before WRC in its 153rd meeting and the Committee decided to grant recognition under section 14(3)(a) of NCTE Act, 1993 and clause 7(11) of NCTE Regulations, 2009 for D.Ed. (M) (CO. ED) with an annual intake of 50 seats from the academic session 2011-2012.
- 10. NOW THEREFORE, in exercise of the powers vested under Section 14 (3) (a) of the NCTE Act, 1993, the Western Regional Committee hereby grants recognition to Rajiv Gandhi D.Ed. College, Survey no. 503 Mauza Chanda, Tehsil + Distt- Chandrapur- 442401 Maharashtra. (APW05356/1221457) for starting D.Ed. (M) (Co.Ed) course of Elementary level of 2 Years with an annual intake of 50 from academic session 2011-2012.
- 11. Further, the institution is required to comply with all post-recognition conditions enumerated from Clause 8(11) to Clause 8(16) of NCTE (Recognition, Norms & Procedure) Regulations 2009.
- 12. The society sponsoring the institution shall transfer and vest the title of the land and building in the name of the institution within a period of six months from the date of this order and submit the documents to the Western Regional Committee. However, in case the society fails to do so due to local laws or rules or bye-laws, it shall intimate in writing with documentary evidence of its inability to do so.
- 13. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms and Procedure) Regulations, 2009 for the academic session 2011-2012 failing which the recognition will be effective from the academic session 2012-2013.
- 14. The recognition will operate for 2011-2012 only if the requirement of 200 teaching days in the session is fulfilled as per calendar of the University /Affiliating Body.
- 15. The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- 16. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its Official website.
- 17. If, at any time, either on *sue-moto* inspection or on any representation received from any person, the WRC, NCTE is satisfied that the institution has contravened any of the provisions of the NCTE Act, or the rules, regulations, orders made or issued there under or any condition subject to which the recognition/permission was granted, the recognition/permission may be withdrawn under the provisions of Section 17 (1) of the NCTE Act.
