Recognition Order

Whereas in terms of Section 15(1) of the NCTE Act, 1993 RASITRIYA SEVA PARISHAD'S, TEACHERS TRAINING COLLEGE OF EDUCATION, BEHIND BHAGWATI CHARANRAM DHAM, CHINCAPADA GAON, CHINCAPADA ROAD, KATEMANVALI, KALYAN (E), TAL-AMBERNATHI, DIST-THANE, MAHARASHTRA has submitted an application (Code No. APW06873/112222 (Revision) (Court Case)) to the Western Regional Committee of NCTE for grant of permission for *enhancement intake* of 10 (Ten) students in existing D.ED. (HINDI) (CO-ED) course of 40 (Forty) students on 05.04.2007. The committee rejected recognition in its 120th Meeting and institution was informed vide letter no. WRC/APW06873/112222 (Revision)/120th/2009/56960 dated 01.07.2009.

And whereas in compliance of Hon'ble High Court ordered dated 10.12.2009 in W.P. No. 10144 of 2009, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee is satisfied that the institution/society fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the ELE teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

And whereas as per decision of WRC in its 26th meeting, the order No. WRC/5-6/26/2K/9716-22 dated 14.11.2000 was issued for recognition of NCTE Code No. 112222 for D.ED. (HINDI) (CO-ED) for 40 intake for academic session 2000-2001.

And whereas as per decision of WRC in its 89th meeting, the order No. WRC/5-6/89/2006/ dated 12.09.2006 was issued for recognition of NCTE Code No. APW02150/ 112222 (ADDL.) for D.ED. (MARATHI) for 50 intake for academic session 2006-2007.

Now, therefore in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Western Regional Committee hereby grants permission to RASITRIYA SEVA PARISHAD'S, TEACHERS TRAINING COLLEGE OF EDUCATION, BEHIND BHAGWATI CHARANRAM DHAM, CHINCAPADA GAON, CHINCAPADA ROAD, KATEMANVALI, KALYAN (E), TAL-AMBERNATHI, DIST-THANE, MAHARASHTRA for an *enhancement intake* of 10 (Ten) (ELE) students in the existing D.ED. course of ELE of 2 year duration with an annual additional intake of 50 (Fifty) (ELE) under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulation 2009. With this the total approved intake for the D.ED. (HINDI) & D.ED. (MARATHI) course will becomes 40+10+50=100 (ELE).

And whereas the grant of recognition will become operational/effective from the academic year from which the ban, imposed by NCTE vide public notice dated 29.07.2009, will be withdrawn.

The admission of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of students shall be completed well before the cut off date prescribed by the examining body for the academic session.

The permission will operate for 2010-2011 only if the requirement of 180 teaching days in the session be fulfilled as per calendar of the University/Affiliating Body.

Post recognition condition are as under :-

- (i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund account into joint accounts to be operated along with an officer of the Western Regional Committee.
- (ii) The institution shall comply with the various other Norms and Standards prescribed in the NCTE Regulations, as amended from time to time.
- (iii) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.
- (iv) Further, the institution should fulfill all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc. wherever applicable.
- (v) The institution shall submit to the Regional Committee a ~~Self-Appraisal Report~~ Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the formal is enclosed with the order.
- (vi) If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.
- (vii) The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:
 - (a) Copy of the Application Form
 - (b) Land and Building Particulars.
 - (c) Staff Profile.
 - (d) Recognition letter.
 - (e) Information for having fulfilled the norms & standard and other required conditions.
