In exercise of the authority vested under Section 14(3)(a) of the National Council for Teacher Education Act, the Western Regional Committee grants provisional recognition to **Govt. B.T.I., Mahasamund, Raipur, M.P.** for the following course -

The institution does not fulfil the requirements for recognition laid down in the regulations notified in accordance with the provisions of the NCTE Act, 1993 and therefore the Committee further lays down conditions which are to be complied as follows-

1. Sanctioned vacant posts should be filled up.
2. Additional staff as per NCTE norms may be sanctioned. For 100 students (50 each year) at least 8 teaching staff members are needed apart from the principal, instructor, technical assistant.
3. Furniture & Equipment as per NCTE norms be provided.

The institution is advised to send a compliance report upto 31 January, 98 as to the fulfilment of deficiencies so that a new team may be sent to verify the same.

ORDER

In exercise of the powers vested under section 14(3) (a) of the National Council for Teacher Education (NCTE) Act, 1993, the Western Regional Committee grants recognition to Govt. Basic Training Institute, Mahasamund, Raipur for D.Ed. course of two year duration from the academic session 2000-2001 with an annual intake of 50 students, subject to fulfilling the following conditions:

1. The institution shall appoint within a period of one year three additional teaching staff possessing the academic qualifications as laid down in the NCTE norms, the salary structure prescribed by the UGC/Central Government/State Government as the case may be.
2. All such teachers already appointed who do not fulfil the NCTE norms shall acquire the qualifications as per the norms within a period of two years of this order.
3. The institution shall ensure library, laboratories and other instructional infrastructure as per the NCTE norms.
4. The admission to the approved course shall be given only to those candidates who are eligible as per the regulations governing the course and in the manner laid down by the affiliating university/State Government.
5. Tuition fee and other fees will be charged from the students as per the norms of the affiliating university/State Government till such time NCTE regulations in respect of fee structure come into force.
6. Curriculum transaction, including practical work/activities, should be organised as per the norms and standards for the course and the requirements of the affiliating university/examining body.
7. Teaching days including practice teaching should not be less than the number fixed in the NCTE norms for the course.
8. The institution, if unaided, shall maintain endowment and reserve fund as per NCTE norms.
9. The institution shall continue to fulfil the norms laid down under the regulations of the NCTE and submit to the Regional Committee the Annual Report and the Performance Appraisal Report at the end of each academic year. The Performance Appraisal Report should inter alia give the extent of compliance of the conditions indicated at 1 to 8 above.
