### RESTORATION ORDER

WHEREAS, the institution, namely, SENDHAWA SHARIRIK SHIKSHA SANSTHAN, (SENDHAWA WELFARE AND EDUCATION COUNCIL), KHASRA NO. 258, VILLAGE: CHATLI (SENDHAWA), BARWANI, MADHYA PRADESH was granted recognition by WRC NCTE for M.P.Ed Course of one year duration with an annual intake of 30 students vide order No.WRC/5-6/106<sup>TH</sup>/2008/40511-40516 dated 27/29.08.2008 followed by corrigendum vide No./WRC/APW06524/224162/224112/2008/47658-47662 dated 03/05.12.2008 to read the course duration as 2 years instead of 1 year.

2. AND WHEREAS, the matter was considered by WRC in its 378th meeting held on 21ST & 22TH December, 2022 and the Committee decided as under:

"The original file of the Institution along with other related documents, Order dated 23.11.2022 in W.P.(C) 16154/2022 passed by Hon'ble High Court of Delhi at New Delhi were carefully examined in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

Recognition was granted for M.P.Ed. course with an intake of 30 vide order dated 29.08.2008 followed by corrigendum dated 05.12.2008 to read the course duration as 2 years instead of 1 year mentioned in recognition order.

The institution was informed vide letter dated 21.11.2013 to have NAAC accreditation as per provisions laid down in Clause 8(5) of NCTE Regulations, 2009.

Show cause notice u/s 17 was issued dated 26.08.2014 to furnish representation regarding accreditation with Letter Grade B under the new grading system developed by NAAC.

Reply vide letter dated 12.09.2014 submitted by the institution (received in WRC,NCTE on 22.09.2014) was considered by WRC in its 212th meeting held on 28-29 November 2014 and the institution was intimated vide letter dated 22.12.2014 to inform the progress regarding NAAC accreditation within 60 days.

Vide letter dated 27.05.2015, the institution attached a copy of a letter dated 12.05.2015 issued by NAAC that it has been accredited with a CGPA of 2.01 on a four-point scale at B Grade valid for a period of five years from 01.05.2015, subsequently forwarded the certificate of accreditation by NAAC dated 01.05.2005 received in WRC, NCTE on 30.07.2015.

The institution vide letter dated 27.02.2016 requested for issuance of revised order mentioning revised intake as per NCTE Regulations, 2014 for M.P.Ed. programme.

Considering para 3.1 of Norms and Standards for M.P.Ed. programme (Appendix-8) under NCTE Regulations, 2014 dated 28.11.2014, there shall be a basic unit of 40 (forty) intake students for each year.

In light of para 5.1 of Norms and Standards for M.P.Ed.programme (Appendix-8) under NCTE Regulations, 2014 dated 28.11.2014, for a basic unit of forty students with a combined strength of eighty for the two-year programme, there shall be 01 Professor, 02 Associate Professors, 03 Assistant Professors, 03 Sports Trainers (part-time) as per the qualification prescribed at para 5.2

of Appendix-8 under NCTE Regulations, 2014. The teachers shall be drawn from various areas of study included in the curriculum.

The institution is required to abide by relevant provisions of NCTE Regulations, and guidelines as amended from time to time.

The latest letter dated 28.09.2022 submitted by the institution requesting for issuance of revised recognition order reflecting revised intake as per NCTE Regulations, 2014 has been considered by WRC.

The institution is required to submit the latest faculty list qualified as per NCTE Regulations, 2014 approved by the affiliating body in accordance with the prescribed proforma of NCTE, along with the approval letter of the same by the concerned affiliating body.

The institutional website needs to be maintained and updated uploading the mandatory disclosure information and related documents in light of Clause 7(14) (i), 8(14) and 10(3) of NCTE Regulations, 2014."

In view of the above, the Committee decided that Show Cause Notice be issued to the institution w/s 17 of the NCTE Act to submit a reply accompanied by an original affidavit within 30 days from the date of uploading of minutes on the website failing which the WRC will take a decision as deemed fit as per the provisions contained in the NCTE Act and Regulations.

- AND WHEREAS, based on the minutes uploaded on the website, the institution has submitted reply
  of Show Cause Notice vide letter dated 05.01.2023 and reply received in WRC on 16.01.2023.
- AND WHEREAS, the matter was again considered in 386<sup>th</sup> meeting of WRC held on 26.05.2023 and the committee decided to issue final show cause notice to the institution.
- AND WHEREAS, Final SCN dated 30.05.2023 was issued to the institution.
- AND WHEREAS, No reply was submitted by the institution within the stipulated time. Therefore, the WRC in its 387th meeting held on 09-10 June, 2023 decided to withdraw the recognition of the institution.
- 7. AND WHEREAS, the institution has filed W.P. 10730/2023 in the Hon'ble High Court of Delhi at New Delhi and the Court had passed an order dated 29.08.2023. The operative part of Court order is as under:-

"In view of the aforesaid submissions, it is discernible that the petitioner was not served with the final Show Cause Notice, allowing the petitioner to submit its response within reasonable period of time. Accordingly, the impugned action of the respondent suffers from violation of principles of natural justice. Accordingly, the Minutes of Meeting dated 9 th -10th June, 2023 in 387th meeting of WRC, is set aside.

6. Let the reply submitted by the petitioner be considered by the concerned regional committee afresh, in accordance with law and it shall take a final decision.

7. Let the final decision, after considering the reply submitted by the petitioner, be taken within a period of 10 days from the date of receipt of copy of the order passed today. The further course, i.e. as to whether the petitioner would continue to be a recognised institution or otherwise, will depend upon the final decision to be taken by the concerned regional committee."

 AND WHEREAS, the matter was considered by WRC in its 393<sup>rd</sup> meeting held on 06.09.2023 the committee decided as follows: "In compliance of order dated 29/8/2023 passed by the Hon'ble High Court of Delhi in the WP (C) No.10730/2023, the case was considered by the WRC and observed that the reply of the institution dated 14.06.2023 is satisfactory.

In view of the above, the committee decided that restoration of recognition for 2 year M.P.Ed course with annual intake of 1 unit(40 seats) be issued to the institution."

NOW THEREFORE, in compliance of order dated 29.08.2023 of the Hon'ble Court of Delhi in W.P. (C) No. 10730/2023 and decision taken by the WRC in its 393<sup>rd</sup> meeting, recognition of the institution viz SENDHAWA SHARIRIK SHIKSHA SANSTHAN, (SENDHAWA WELFARE AND EDUCATION COUNCIL), KHASRA NO. 258, VILLAGE: CHATLI (SENDHAWA), BARWANI, MADHYA PRADESH for conducting for 2 year M.P.Ed course with annual intake of 1 unit(40 seats) is hereby restored.
