- 3. AND WHEREAS, Revised Recognition order was issued for two basic units of (50 students each) to the institution on 26.05.2015.

AND WHEREAS, the standing decision of WRC taken in the 255th meeting held on 22-24 June, 2016 regarding issue of SCN to all cases who have not complied NCTE Regulation 2014 and the Committee decided that "...Follow up of Revised Orders for B.Ed. courses. The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item.
- 5. AND WHEREAS, the Compliance Show Cause Notice was issued to the institution on 10.01.2017 and the reply of SCN was received on 31.01.2017.
- 6. AND WHEREAS, the matter of the institution for the B.Ed. course (Code No. APW06883/223731) was placed in **305**th **Meeting held on April 15**th **-16**th, **2019** of WRC and the Committee decided that "...The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -

The revised recognition order was issued to the institution on 26/05/2015. The SCN was issued to the institution on 10/01/2017. The institution has submitted reply of clarification letter on 28/01/2017.

On perusal of the reply of the institution the committee decided to continue recognition for B.Ed. course of two years duration for two units (100 students) and to issue a formal recognition order accordingly."
