With reference to the above, it is to inform that as per NCTE Regulations, 2014 a revised recognition order no. WRC/APW05881/323463/2015/143163 dt. 31.05.2015 was issued to the institution for conducting 2015-2016.

The WRC in its  $295^{th}$  meeting, held on July  $30^{th}-31^{st}$ , 2018, considered the Appellate Authority order dt. 12.07.2018 alongwith reply dt. 02.07.2018 submitted by the institution and decided as follows:

"The case file was seen. This is a case of appeal. The Appellate Authority vide order dated 12.07.2018 has remanded the case to WRC for further processing the application.

The WRC examined the file and found that the institute has now submitted a staff profile of 1 Principal M.Ed. degree and should not be appointed.

Hence, Recognition is restored for two units of B.Ed. course."

Therefore, the recognition granted to the institution for conducting B.Ed. course has been restored and revised recognition order no. WRC/ APW05881/323463/2015/143163 dt. 31.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two basic units of 50 students) will

It is also informed that the institution shall continue to follow the NCTE Regulations, 2014 and any deviation from it will be liable for action, against the institution, as defined under NCTE Act, 1993 and NCTE Regulations, 2014.
