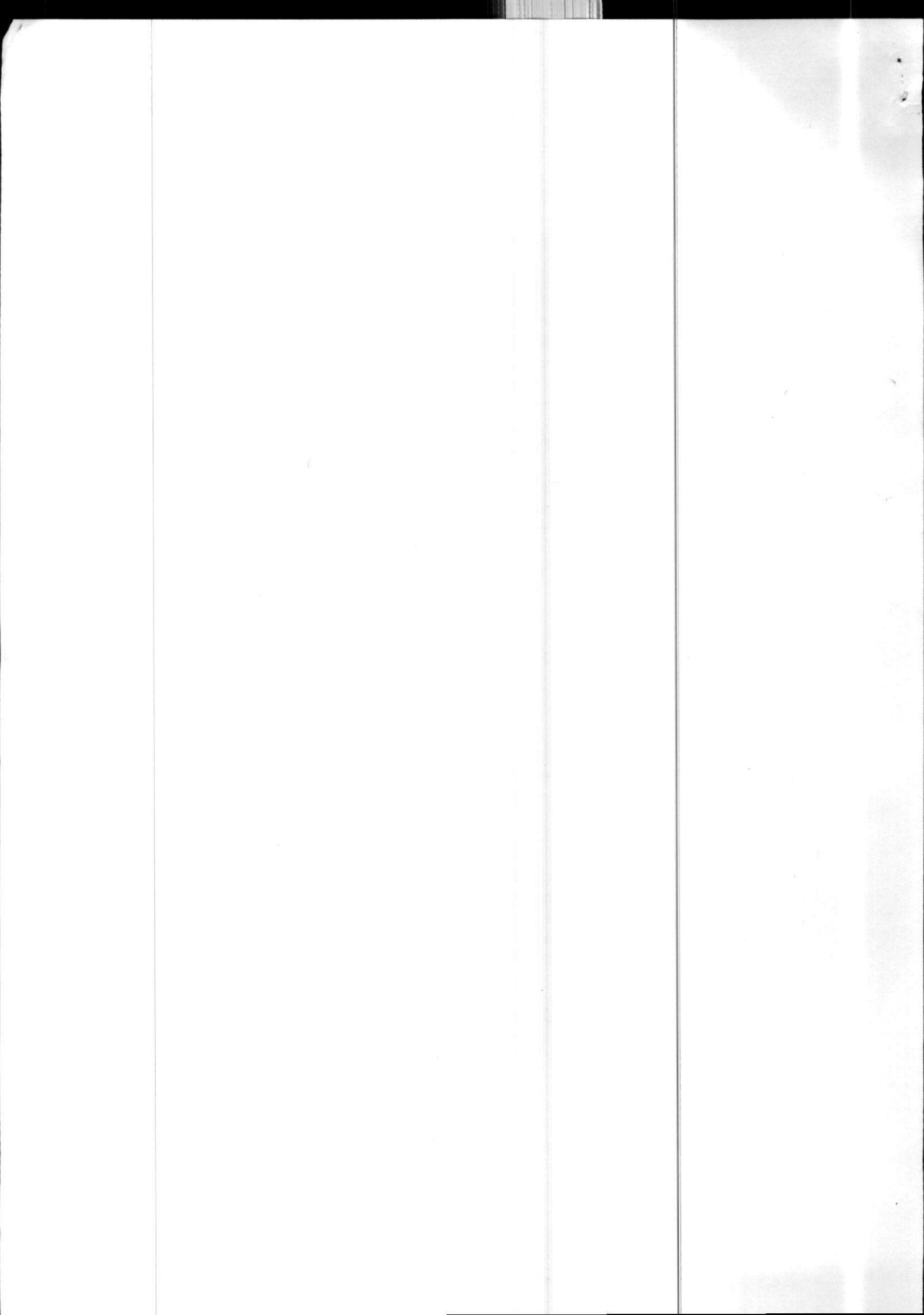

7. If the institution contravenes any of the above conditions or any of the provisions of the Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw its recognition under the provisions of Section 17(1) of the NCTE Act.

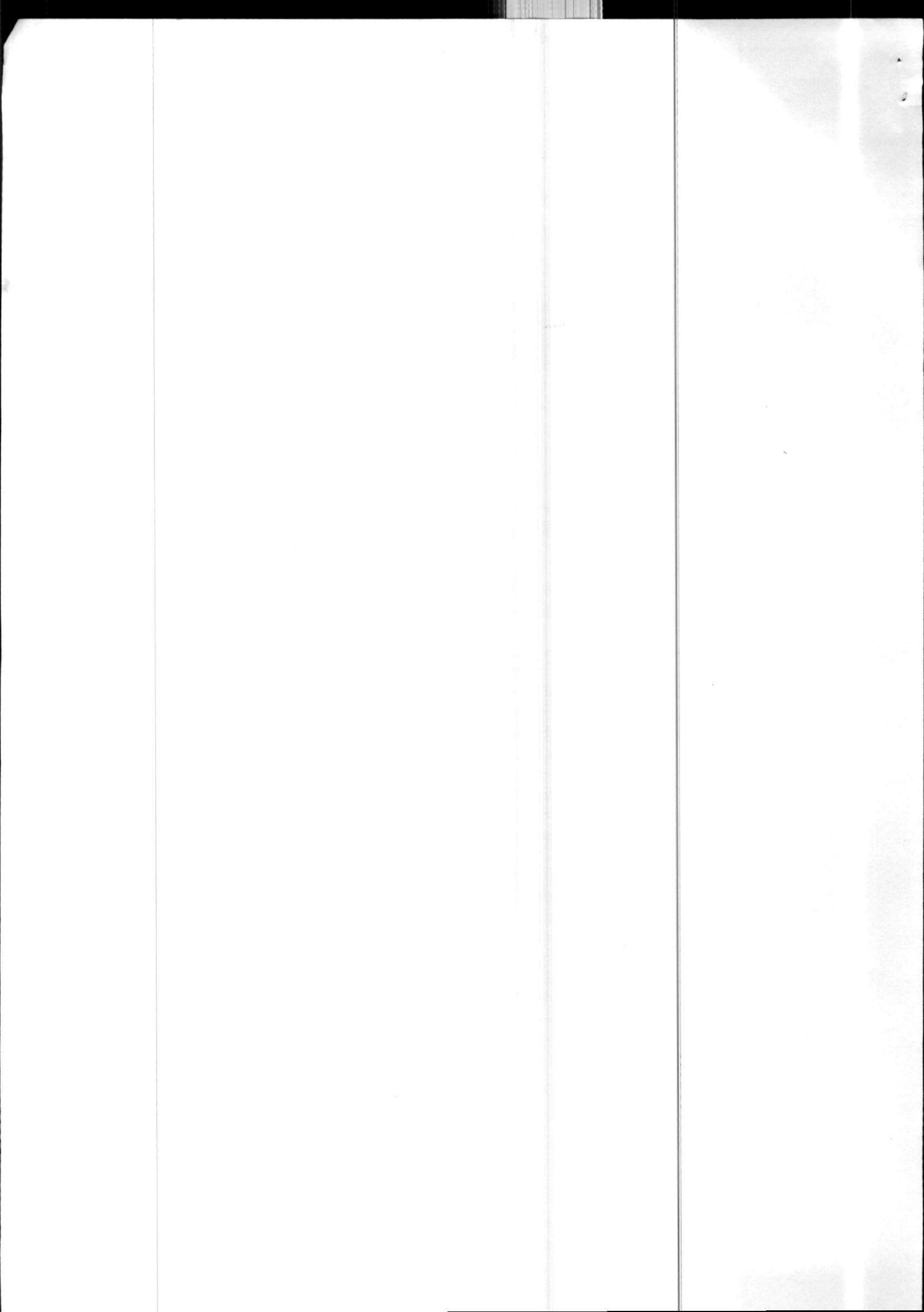
