Recognition Order

Whereas, in terms of Section 14(1) of the NCTE Act, 1993 Ramrao Patil D.Ed College, Adarsh Bahuuddeshiya Sevbhavi Sanstha, Plot No. 5-3-482 and 5-3-48, Main Road, Udgir, Tq. Udgir, Latur, Maharashtra has submitted an application (Code No-APW03784/122747) to the Western Regional Committee of NCTE for grant of recognition for D.Ed. (M) (Co-Ed) course with an annual intake of 50 (Fifty) (ELE) students on 04.09.2006.

And whereas, the inspection of the institution was conducted by visiting team experts on 13-14.10.2008.

And whereas, the matter was placed before the Western Regional Committee WRC in its 110th meeting and WRC decided that no further processing will be done in this case as per instruction received for NCTE, New Delhi in the light of letters no. F.No. 46-3/2008/NCTE (N&S)/84003 dt. 17 Sep, 2008, F.No. 49-27/2007/NCTE (N&S) dt. 1 October, 2008 and F.No. 49-27/2007/NCTE (N&S) dt. 1 October, 2008 and negative recommendation received from Maharashtra State Government in respect of D.ED. Course. Order to this effect was issued to the institution on 10.04.2009.

And whereas, the institution had preferred an appeal before the Council under section 18 of the NCTE Act 1993. The Council Vide Appeal order no. F.No. 89-319/2009-Appeal 98184 dated 14.07.2009 confirmed the order of WRC.

And whereas, the institution had also filed a Writ Petition No. 5828/2009 before the Hon'ble High Court of Judicature at Bombay and the court had passed an order dated 28.06.2010.


And whereas, the case of the said institution in compliance of the court order was considered by WRC, in its 150th meeting held on 02nd to 4th June, 2011 and in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Western Regional Committee hereby grant recognition to Ramrao Patil D.Ed College, Adarsh Bahuuddeshiya Sevbhavi Sanstha, Plot No. 5-3-482 and 5-3-48, Main Road, Udgir, Tq. Udgir, Latur, Maharashtra. for with an annual intake of 50 (Fifty) (ELE) from the academic session 2010-2011 under clause 7(11) of the NCTE (Recognition Norms & Procedure) Regulations 2009.

The admission of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of students shall be completed well before the cut off date prescribed by the examining body for the academic session 2010-2011, failing which the recognition will be effective from the academic session 2011-2012.

The recognition will operate for 2010-2011 only if the requirement of 200 teaching days in the session be fulfilled as per calendar of the University/Affiliating Body.

Post recognition condition are as under :-

- (i) The institution shall comply with the various other Norms and Standards prescribed in the NCTE Regulations, as amended from time to time.
- (ii) The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.

- (iii) Further, the institution should fulfill all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc., wherever applicable.
- (iv) The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff. A copy of the formal is enclosed with the order.
- (v) If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as stipulated provisions of Section 17(1) of the NCTE Act.
- (vi) The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:
 - (a) Copy of the Application Form
 - (b) Land and Building Particulars.
 - (c) Staff Profile.
 - (d) Recognition letter.
 - (e) Information for having fulfilled the norms & standard and other required conditions.

(M) (CO-ED) Course in ELE Course of 2 year(s) duration under Section 14 of the NCTE Act, 1993 to the WRC, NCTE on 04-Sep-06.

AND WHEREAS, The inspection of the Institution was conducted on 13.10.2008 and WRC considered the case of the institution in light of letters F.No.46-3/2008/NCTE(N&S)/84003 dt. 17 Sep, 2008, F.No. 49-27/2007/NCTE(N&S) dt. 1 October, 2008 and F.No. 49-27/2007/NCTE(N&S) dt. 31 October, 2008 received from Member Secretary, NCTE, New Delhi and negative recomanodation received from Maharashtra State Govt. in respect of D.Ed. Keeping in view of the negative recommendation received from the Maharashtra State Government in respect of D.Ed. course and directions received from NCTE Hqs, the WRC decided that no further processing will be done in this case and communication to this effect to be made to this institution.
