RECOGNITION ORDER

Whereas in terms of Section 14(1) of the NCTE Act, 1993, Shri Baneshwar Shikshan Sanstha, Plot No. 10/1, At. Post. Burhannagar Tal. Nagar, Dist. - Ahmednagar - 414002, Maharashtra (APW04791/1221147) had submitted an application to the Western Regional Committee of the NCTE on 28.12.2006 for grant of recognition for starting the D.Ed. (M) (Co.Ed.) Course with an annual intake of 50 students

And whereas, the WRC had constituted a Visiting Team to visit the institution, which had visited the institution on 23.10.2008. and had submitted its report.

And whereas, in the light of letters F.No.46-3/2008/NCTE(N&S)/84003 dt. 17 Sep, 2008, F.No. 49-27/2007/NCTE(N&S) dt. 1 October, 2008 and F.No. 49-27/2007/NCTE(N&S) dt. 31 October, 2008 received from the Member Secretary, NCTE, New Delhi and the negative recommendation received from the Maharashtra State Govt. in respect of D.Ed. Course, the WRC in its 110th meeting decided that no further processing will be done in this case and communication to this effect to be made to the institution. The decision of WRC was conveyed vide letter No. APW04791/1221147/110th/VTR/2008/54461 dated 21.04.2009 to the institution.

And whereas, the institution had preferred an appeal before the Council (NCTE) under section 18 of the NCTE Act, 1993. The Appellate Authority of NCTE, New Delhi vide its order No. 89-1382/2009-Appeal A 28033 dated 19.11.2010 accepted the appeal and reversed the WRC's order dated 21.04.2009 with direction to the WRC to reconsider the case on merit in the light of the court direction.

And whereas, the Appeal Order dated 19.11.2010 was considered by WRC in its 144th meeting held with effect from Jan. 29th - 31st, 2010 and the Committee decided to seek clarification on the following points:

- **College be asked to submit certified copy of registered land deed.**

And whereas the letter seeking clarification was issued on 17.02.2011. The reply dated 24.02.2011 was considered by WRC in its 147th meeting held with effect from March 24th - 25th, 2010 and the Committee decided that SCN be issued on the following points:-

- **Certified copy of registered land documents not submitted.**

And whereas the Show Cause Notice was issued to the institution on 09.04.2011.

And whereas, the reply of the institution dated 18.04.2011 alongwith other documents was considered by the WRC in its 150th meeting held with effect from 02-04 June, 2011 and the Committee decided that letter of intent under clause 7(9) of the NCTE Regulations, 2009 be issued to the institution. The letter of intent was issued to the institution on 20.06.2011. 010

And whereas, reply dated 12.07.2011 received on 15.07.2011 alongwith supporting documents was placed before WRC in its 153th meeting held with effect from July 28th - 30th, 2011 and the Committee decided to issue Show Cause Notice, on the following points:-

- **Lecturer in Arts/Music and Physical Education are not qualified as per the NCTE norms.**

And whereas, the show cause notice issued to the institution on 26.09.2011. The reply submitted by the institution was considered by WRC in its 156th meeting held with effect from Nov. 11th to 12th, 2011 and the Committee decided to grant recognition.

Now therefore, in exercise of the powers vested under Section 14 (3) (a) of the NCTE Act, 1993, the Western Regional Committee hereby grants recognition to Shri Baneshwar Shikshan Sanstha, Plot No. 10/1, At. Post. Burhannagar Tal. Nagar, Dist. - Ahmednagar - 414002, Maharashtra (APW04791/1221147) for starting D.Ed. (M) (Co.Ed) Course of (Elementary) level of 2 Years with an annual intake of 50 (students) from the academic session 2012-2013.

4. Further, the institution is required to comply with all post-recognition conditions enumerated from Clause 8(11) to Clause 8(16) of NCTE (Recognition, Norms & Procedure) Regulations 2009.

5. The society sponsoring the institution shall transfer and vest the title of the land and building in the name of the institution within a period of six months from the date of this order and submit the documents to the Western Regional Committee. However, in case the society fails to do so due to local laws or rules or bye-laws, it shall intimate in writing with documentary evidence of its inability to do so.

6. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms and Procedure) Regulations, 2009.

7. The institution shall ensure that the required number of academic staff for conducting the course is always in position.

8. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its Official website.

9. If, at any time, either on *sue-moto* inspection or on any representation received from any person, the WRC, NCTE is satisfied that the institution has contravened any of the provisions of the NCTE Act, or the rules, regulations, orders made or issued there under or any condition subject to which the recognition/permission was granted, the recognition/permission may be withdrawn under the provisions of Section 17 (1) of the NCTE Act.
