College, Mogri, Anand for B.Ed. of one year from the academic session 2003-2004 with an annual intake of 100 students subject to fulfillment of the following.
- The institution shall ensure that it gets duly affiliated for this course to the concerned University and all other formalities required by the University are also completed before (a) the commencement of the course and admission of the students to the course and a report to this effect should be sent to the Committee.
- That the institution will ensure that 08 (one Principal and 07 lecturers) faculty members are in position for an intake of 100 students before commencement of the course and a report to this (b) effect duly verified by the Registrar of the concerned University shall be sent to the Committee within one month of commencement of the course.
- The institution shall within one month of the receipt of recognition create an endo v nent fund account into a joint account to be operated along with an official of the Regional Committee. (c)
- The institution shall shift to its own premises within three years from the date of recognition (d) (In case the course is started in rented premises).
- The institution shall comply with the various other norms and standards as prescribed in the (e) NCTE Regulations. PTO

- 4. Recognition is subject to the condition that the affiliating University shall ensure that, among other things, an institution has appointed required number of faculty members (including Principal/Head of Department) as per the norms of the NCTE/State Government.
- 5. Further, the recognition is subject to the fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.
- 6. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating university/State Directorate of Education to the appointment of faculty members and the statement of annual accounts duly audited by a Chartered Accountant.
- 7. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.

ORDER

In exercise of the powers vested under section 14(3) (a) of the National Council for Teacher Education(NCTE) Act, 1993, the Western Regional Committee grants recognition to Charotrar Education Society's Ishwarbhai Jethabhai Patel B.Ed. College, Mogri, Anand, Dist. Kheda for B.Ed. course of one year duration from the academic session 2000-2001 with an annual intake of 60 students, subject to fulfilling the following conditions:

- The institution shall shift to its permanent building within a period of one year, if temporarily housed elsewhere.
- The institution shall ensure library, laboratories and other instructional infrastructure as per NCTE norms.
- The admission to the approved course shall be given only to those candidates who are
 eligible as per the regulations governing the course and in the manner laid down by the State
 Government.
- Tuition fee and other fees will be charged from the students as per the norms of the State Government till such time NCTE regulations in respect of fee structure come into force.
- Curriculum transaction, including practical work/activities, should be organised as per the NCTE norms and standards for the course and the requirements of the examining body.
- Teaching days including practice teaching should not be less than the number fixed in the NCTE norms for the course.
- 7. The institution, if unaided, shall maintain endowment and reserve fund as per NCTE norms.
- 8. The institution shall continue to fulfil the norms laid down under the regulations of the NCTE and submit to the Regional Committee the Annual Report and the Performance Appraisal Report at the end of each academic year. The Performance Appraisal Report should inter alia give the extent of compliance of the conditions indicated at 1 to 7 above.
