#### **REVISED ORDER**

Whereas, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993, and in super session of the National council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

- 2. And Whereas, the Recognition was granted to the institution namely, DEPARTMENT OF EDUCATION, SARDAR PATEL UNIVERSITY, VALLABH VIDYANAGAR, DIST- ANAND, GUJARAT, for M.Ed. Course vide order No. WRC/5-6/15/99/5350-5353 dt. 10.09.1999 with an annual intake of 20 students.
- 3. And Whereas, the Recognition was granted to the institution namely, **DEPARTMENT OF EDUCATION**, **SARDAR PATEL UNIVERSITY**, **VALLABH VIDYANAGAR**, **DIST- ANAND**, **GUJARAT**, for **M.Ed**. Course vide order No. WRC/5-6/22/2000/8408-13 dt. 11.10.2000 with an annual intake of 30 students.
- 4. And whereas, the matter was placed in 363<sup>rd</sup> meeting of the WRC held on 19<sup>th</sup> to 20<sup>th</sup> May, 2022 and the Committee decided as follows:-
  - "...The original file of the Institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the following observation was made that:
  - 1. The Recognition was granted to the institution on 10.9.1999 for M.Ed. course of one year duration.
  - 2. After promulgation of NCTE Regulation 2014 Revised Recognition order was not issued for two year M.Ed. programme due to non-submission of affidavit by the institution.
  - 3. The Institution has submitted annexed an affidavit (dt. 22.1.2015) in its e-mail dt. 17.5.2022 for acceptance of NCTE Regulation 2014 with a request to issued revised Recognition order for M.Ed. two-year programme with an intake of 50 seats.

In view of above, the Committee considered the request and decided that the Revised Recognition Order for M.Ed. two-year programme with an annual intake of 50 students be issued to the university."

- 4. Now therefore, in the light of the above and in accordance with the NCTE Regulations, 2014, the Western, Regional Committee (NCTE) hereby issues the revised recognition order to DEPARTMENT OF EDUCATION, SARDAR PATEL UNIVERSITY, VALLABH VIDYANAGAR, DIST- ANAND, GUJARAT, for conducting M.Ed. programme of two years duration with an annual intake of 50 students (one basic unit).
- 5. Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/body, the State Government etc, as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.
- 6. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.
