Whereas SADGURU EDUCATION SOCIETYS COLLEGE OF PHYSICAL EDU, KHAJAMIYA DARGHA, GANESH COLONY, JALGAON 425001 MAHARASHTRA has applied in the office of WRC on 31.03.2006 for grant of permission for *enhancement of intake* of 20 students in the existing M.P.Ed. course with an annual intake of 10 students under section 15 of NCTE Act, 1993.

And Whereas, the deficiency letter was issued to the institution on 24.08.2006 for removal of the same. The reply submitted by the institution was considered by WRC in its 112th meeting and as per decision of WRC, the application was rejected vide order No.WRC/APW03433/124004/112/2008/48916 dated 24.12.2008.

And Whereas, the institution has preferred an appeal before the Council (NCTE) under section 18 of NCTE Act, 1993 against the above referred order of WRC. The Council order No.89-465/2009-Appeal/A 3400 dated 29.09.2009 accepted the appeal and WRC order dated 24.12.2008 was set aside and remand back the case to WRC for causing an inspection of the institution to ascertain the availability of infrastructure and instructional facilities, as per NCTE norms and thereafter pass appropriate order for enhancing the intake from the existing 10 to 30 students in the M.P.ED. programme.

And Whereas, in compliance of Appeal order dated 29.09.2009, inspection of the institution was conducted on 24.02.2010 and visiting team report was considered by WRC in its 133rd meeting and decided that institution does not full fill the requirement of NCTE Regulations, and Norms & Standards prescribed by NCTE for M.P.Ed. course, hence show cause notice issued to the institution vide letter No.WRC/APW03433/114004/133rd/2010/67428 dt. 29.04.2010.

And Whereas, the applicant institution has not submitted any representation to WRC, NCTE the matter was again considered by the Western Regional Committee in its 139th meeting held on August 13-14, 2010, and it was decided to withdraw recognition for conducting M.P.Ed. course with an annual intake of 10 students vide order No.WRC/APW034/114004/139th/2010/70637-70642 dt. 13.09.2010.

And Whereas, the institution has preferred another appeal before the Council (NCTE) under section 18 of NCTE Act, 1993 against the above referred order of WRC. **The Council vide its order No.33-1045/2010-Appeal/A 29432 dated 23.12.2010 has reverses the WRC order dated 13.09.2010 with direction to the WRC to issue revised orders refusing recognition for enhancement of intake of 20 only, without affecting the originally sanctioned intake of 10.**

And Whereas, the order passed by NCTE, New Delhi dated 23.12.2010 was placed in 145th meeting of WRC held on February 17-18, 2011 and Committee decided that "As per the order of the appellate authority the recognition of M.P.ED be revived with original intake of 10"

Now therefore, as per above decision taken by WRC in compliance to order passed by appellate authority of NCTE, New Delhi the recognition granted to the institution vide WRC order No.WRC/5-6/36/2002/04346-52 dt. 03.08.2002 with an annual intake of 10 students stands recognized.


