**CONTINUATION ORDER**

WHEREAS, the institution, namely, **EKTA COLLEGE OF EDUCATION (B.ED) EKTA TRUST. AT & POST NAVI METRAL, TAL. KHED BRAHMA, SABARKANTHA-383270, GUJARAT** was granted recognition by WRC NCTE for B.Ed. Course with an annual intake of 100 students vide Order No.WRC/2-32/323190/73/2005/4811 dated **24.06.2005**.

2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the revised recognition order was issued to the institution vide order No.WRC/APW00857/323190/2015/145260,260,263, 267,268,271,275,283 dated **31.05.2015** for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-2016 with certain conditions.

3. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order was placed in the 255<sup>th</sup> WRC meeting held on June 22-24, 2016 and the Committee decided that show cause notice be issued to all such institutions which have not submitted compliance.


4. AND WHEREAS, Show Cause Notice was issued to the institution dated **22.08.2016**.

5. AND WHEREAS, in response to the aforesaid show cause notice reply submitted by the institution on dated **16.09.2016 & 02.05.2017**.

6. AND WHEREAS, the matter was placed in **321<sup>st</sup> WRC meeting held on November 09-11, 2020**, and the Committee decided as under:-

*"The original file of the institution along-with other related documents were carefully considered and examined by WRC in the light of NCTE Act. 1993, Regulations and Guidelines issued by NCTE from time to time and following observation was made that:*

1. This RPRO case.
2. The institution is required copy of land documents issued by concerned Tehsildar / Revenue office.
3. The institution is required to submit Land Possession/Mutation certificate issued by land Revenue.
4. The institution is required to submit Non-Encumbrance certificate issued by land Revenue Department.
5. The institution is required to submit a building plan duly approved by the competent authority mentioning the total land and built up area.
6. The institution has submitted a building completion certificate but total land area is not mentioned. The institution is required to submit a BCC duly approved by the Govt. Civil Engineer mentioning total land area of the institution.
7. The institution has not appointed teaching faculty for Music & Fine Arts.
8. The institution is required to submit a latest faculty list duly approved by concerned affiliating body as per NCTE Regulation 2014 and amended Regulation time to time alongwith faculty approval letter issued by the concerned affiliating university.

*In view of the above, the Committee decided that last Show Cause Notice be given to the institution to reply within 30 days u/s 15 of the NCTE Act for B.Ed. programme.”*

7. AND WHEREAS, Final Show Cause Notice was issued to the institution on **16.12.2020**.
8. AND WHEREAS, reply not submitted by the institution.
9. AND WHEREAS, the matter was placed in 371<sup>st</sup> meeting held on September 21-22, 2022 and the Committee decided as under:-

*“The original file of the Institution along-with other related documents were carefully examined in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:*

- *Initial recognition was granted to B.Ed. course of one year dated 24.06.2005.*
- *Revised order was issued for B.Ed. course of two years dated 31.05.2015.*
- *In the matter of compliance of revised recognition in light of NCTE Regulations, 2014, 1<sup>st</sup> Show cause notice issued dated 22.08.2016.*
- *Final show cause notice issued dated 16.12.2020.*
- *The institution has not submitted reply of final show cause notice.*
- *The institution is still deficient on the grounds mentioned in the final show cause notice dated 16.12.2020.*

*In view of the above, the Committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order.”*


10. AND WHEREAS, the matter was again placed in 373<sup>rd</sup> WRC meeting held on October 8, 2022 and the Committee decided as under:-

*“The decision taken by WRC for withdrawal of recognition as recorded at Sl.No.6 of minutes of 371<sup>st</sup> Meeting held on 21<sup>st</sup>& 22<sup>nd</sup> September, 2022 be modified and read as under:*

*The original file of the Institution along-with other related documents, representation dated 27.09.2022 received on 28.09.2022 in response to final show cause notice regarding fulfillment of conditions in light of Revised Recognition order were carefully examined in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee decided that the institution has fulfilled the criteria laid down under extant NCTE Regulations, 2014 (as amended time to time).*

*In view of the above, the Committee decided that recognition to B.Ed. course be continued. Hence, order of continuation of recognition to B.Ed. course of two years duration be issued to the institution, affiliating body/State Government and all others concerned accordingly.”*

11. **NOW THEREFORE, Recognition of EKTA COLLEGE OF EDUCATION (B.ED) EKTA TRUST. AT & POST NAVI METRAL, TAL. KHED BRAHMA, SABARKANTHA-383270, GUJARAT for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units of 50 students each) is permitted to continue.**




