## **RESTORATION ORDER**

WHEREAS, recognition was granted to the institution, namely to LATE MADHAVRAO TIDAK SHARIRIK SHIKSHAN MAHAVIDYALAYA, MOUDA, TA.- MOUDA, DIST-NAGPUR, MAHARASHTRA, under section 14 (3)A of NCTE Act, 1993 for conducting B.P.Ed. course (50 Intake) vide order No. WRC/5-6/107/2008/44221-44226 dated 25.09.2008.

AND WHEREAS, Revised Recognition order was issued to LATE MADHAVRAO TIDAK SHARIRIK SHIKSHAN MAHAVIDYALAYA, MOUDA, TA.- MOUDA, DIST-NAGPUR, MAHARASHTRA, vide order No. F.No. WRC/APW00693/124022/2015/147166-173 dated 31-05-2015 for B.P.Ed. of Two Years Duration with an annual intake of 100 students (Two basic unit of 50 students) from the academic session 2015-2016.

- 2. **AND WHEREAS,** the matter was placed in 255<sup>th</sup> Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."
- 3. **AND WHEREAS,** a Show Cause notice was issued to the institution on 22.08.2016 for not submitting the documents in compliance of Regulation 2014 mentioned in the revised order.
- 4. AND WHEREAS, the reply of show cause notice was not submitted by the institution.
- 5. **AND WHEREAS**, the matter was placed in 280<sup>th</sup> Meeting held on August 31 & September 01th 2017 of WRC and the Committee decided that." The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -

"...The case file was seen. Show Cause Notice was issued to the institution on 22.08.2016. The institute has not replied till date.

Hence, Recognition is withdrawn from the session 2018-2019.

FDRs, if any, be returned."

- 6. AND WHEREAS, a Withdrawal order was issued to the institution on 05-09-2017.
- 7. **AND WHEREAS,** the institution has filed an appeal against the Withdrawal order dt. 05.09.2017 and the Council vide its order dt 05.10.2018 confirm the case.
- 8. **AND WHEREAS,** the institution had approach to the Hon'ble High Court of Delhi At New Delhi. W.P. (C) No. 10742/2019 dt. 21.12.2021 the operative part is produced here below:-.

"...In the aforesaid circumstances, the impugned orders dated 05.09.2018 are set aside, and the proceedings are remanded to the WRC for issuance of a second show Cause Notice, if necessary. The WRC will thereafter take a fresh decision in accordance with law, and communicate the same to the petitioner.

As the impugned orders of withdrawal are being set aside, the WRC is directed to issue an order of restoration of recognition in favour petitioner within one week from today and also to update its website to reflect the status of the petitioner as a recognised institution. The respondents will also communicate the same to the petitioner's affiliating University, as well as to the concerned State Government."
