Sub: Conveying decision of 293rd WRC Meeting- reg.

Sir/Madam,

With reference to the above, it is to inform you that a show cause notice dt. 02.09.2016 was issued to the institution for non compliance of conditions mentioned in revised recognition order dt. 20.05.2015.

The reply dt. 20.09.2016 of the institution was placed before the WRC in its 293rd meeting held on June 12th - 14th, 2018. The Committee has decided as under:-

"The case file was seen. Consequent to the issue of Revised Recognition order, Show Cause Notice dated 02.09.2016 was issued and the institute replied on 20.09.2016.

The institute is running four units of B.Ed. (APW01985/723076) and one unit of M.Ed.(APW04132/725009) courses. As such the requirements of the :-

- a) For M.Ed.; Two Professors, Two Associate Professors, and Six Asst. Professors (as per Appendix V of the NCTE Regulations).*
- b) For B.Ed.(four units); One Principal/HOD and Thirty faculty members as per Appendix-IV of NCTE Regulations, 2014.*

The institute should submit the above staff profiles in original separately approved by the Registrar.

Further, the institute should ensure that FDRs for 12 Lakhs in original in Joint name with the RD is submitted for the M.Ed. course and similar amount for the B.Ed. course.

Show Cause Notice was issued to the institution for its B.Ed. Course (APW01985/723076). Reply has not been received so far.

Hence, Compliance should be submitted by the institution within one month, failing which Recognition for both the B.Ed. & M.Ed. courses will be withdrawn.

The WRO should submit both the files together."

Therefore, you are hereby informed to submit the required documents within **30 days from the date of issue of this letter** failing which recognition will be withdrawn under section 17 of NCTE ACT, 1993.
