## ORDE

Whereas, the institution Ayush College of Education Marwahi, Polt No. 725, Village – Lohari, City – Marwahi, District – Bilaspur, Chhattisgarh - 495118 for conducting B.Ed. course of one year duration vide order No. WRC/APP1089/152<sup>nd</sup>/B.Ed./2011/80982-88 dated 30.08.2011 with an annual intake of 100 students.

- 2. **AND WHEREAS** on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dt. **12.01.2015.** for its willingness of Two basic units in B.Ed. course and adherence of provisions of new Regulations.
- 3. AND WHEREAS, provisional revised recognition order was issued on dt. 31.05.2015 to the institution on for conducting B.Ed. course of two years duration with an annual intake of 100 seats (two units of 50 students each) from the academic session 2015-2016.
- 4. **AND WHEREAS**, the reply **30.10.2015** submitted by the institution and the matter was placed before the WRC in its **285th** Meeting held on **December 19-21,2017** and as decided to issue the show cause notice u/s 17(1) on **29.07.2016** to the institution.
- 5. **AND WHEREAS**, replied dt. <u>23.08.2016</u> submitted by the institution was placed before the WRC in its <u>283<sup>rd</sup></u> meeting held on <u>November 14<sup>th</sup>-15<sup>th</sup></u>, <u>2017</u> and the committee decided as follows:-

"The case file was seen. In response to Revised Recognition order dated 31.05.2015, the institution was directed to submit documents related to staff, funds and Building Completion Certificate.

The institution vide letter dated 30.10.2015 has submitted an approved list of 1+15 faculty members.

However, Building Completion Certificate in the prescribed format and counter signed by a Govt. Engineer should be submitted in original.

Hence, Show Cause Notice be issued as to why recognition should not be withdrawn. Reply should be submitted within one month."

- 6. AND WHEREAS, a Show Cause Notice no. <u>WRC/APP1089/285<sup>th</sup>/B.Ed./C.G.</u>/2017/10324-325 dt. <u>03.01.2018</u> was issued to the institution.
- 7. **AND WHEREAS**, reply dt. <u>22.01.2018</u> submitted by the institution was placed before the WRC in its <u>314<sup>th</sup></u> meeting held on  $\underline{13^{th} 15^{th}}$  and  $\underline{22^{nd}}$  July, <u>2020</u> considered the matter and committee decided as follows:-

This is a RPRO case. RPRO issued on 31.05.2015 for two units of B.Ed programme. SCN issued on 03.01.2018 and reply received on 22.01.2018.

After examination, all the documents required in response to show cause notice are found to be satisfactory.

In view of the above, the Committee decided that the recognition granted to the institution be permitted to continue the existing B.Ed course with two units.

- 8. Now Therefore, the WRC decided to permit the institution i.e. Ayush College of Education Marwahi, Polt No. 725, Village Lohari, City Marwahi, District Bilaspur, Chhattisgarh 495118 for continuation of recognition for B.Ed. course of two-years duration with an intake of 100 students (Two basic unit) subject to fulfilment of the following conditions:
  - a) The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - b) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - c) The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - d) The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
  - e) The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 9. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc. as applicable.
- 10. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 11. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a) Sanctioned programme(s) along with annual intake in the institution.
  - b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c) Name of faculty members who left of joined during the last, quarter:
  - d) Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
  - e) Free charged from students.

- f) Available infrastructural facilities.
- g) Facilities added during the last quarter;
- h) Numbers of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information, if it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 12. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its officials website.
- 13. The institution shall make available the list of students admitted on its officials website.
- 14. The institution shall fill the information on GIS Portal on the NCTE Website.
- 15. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Western Regional Committee under the provisional of Section 17 of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
