ORDER

WHEREAS, in terms of section 14/15 of the NCTE Act. 1993 the institution CHOUDHARI TEACHER TRAINING COLLEGE, PLOT No. 1003,1003/1, STREET/ROAD – NH – 8, SANGTEDA, KOTPUTLI, DISTRICT – JAIPUR, STATE-RAJASTHAN submitted online application in 27.05.2015 for grant of recognition to B.A.B.Ed. /B.SC.B.ED. four year integrated course.

2. **AND WHEREAS,** the matter was considered by NRC in its 299th and 300th meeting the committee decided as under:

The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by NRC and the following observation was made: -

The Committee decided that recognition be granted to the institution for BA.B.Ed. Course for two units (100 students) under clause 7(16) of the NCTE Regulations, 2014 from the academic session 2020-21.

- 3. AND WHEREAS, NRC, NCTE has granted the recognition/permission under section 14(1)/15(1) of the NCTE Act, 1993 to the institution namely, CHOUDHARI TEACHER TRAINING COLLEGE, PLOT No. 1003,1003/1, STREET/ROAD NH 8, SANGTEDA, KOTPUTLI, DISTRICT JAIPUR, STATE-RAJASTHAN for conducting the BA.B.Ed. Course of one-year(s) duration with an annual intake of 100 students vide NRC order no. NRC/NCTE/NRCAPP-10749/300th Meeting/2019/202374-79 dated: 26.04.2019.
- 4. **AND WHEREAS**, the institution filed an appeal to the Appellate Authority Hqrs. against the decision of NRC in granting only BA.B.ED. course and the Appellate Authority vide order dated 27.08.2019 remanded back the case to NRC.
- 5. **AND WHEREAS**, the matter was considered by NRC in its 310th meeting held from 20th to 22nd November 2019 and the committee decided as under: -

The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by NRC and the following observations were made that: -

- 1. As per the documents submitted by the institution there is no proof that B.Sc. course is being run by the college hence recognition for B.Sc.B.Ed. was not granted and two units for BA.B.Ed. were given.
- 2. Institution is directed to submit the proof of running B.Sc. course prior to the recognition by NCTE.

Hence, show cause notice under Section 14/15 (3)(b) of the NCTE Act, 1993 be issued to the institution to submit reply within 30 days from the date of issue of show cause notice.

- 6. **Accordingly,** Show Cause Notice was issued to the institution. The institution has submitted reply of show cause notice vide letter dt. 07.12.2019 received on 13.12.2019.
- 7. **AND WHEREAS,** the reply of the institution was considered by NRC in its 311^{th} meeting held from $16^{th} 17^{th}$ January 2020 and the committee decided as under: -

The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by NRC and the following observations were made that: -

- 1. As per the documents submitted by the institution there is no proof that B.Sc. course is being run by the college hence recognition for B.Sc.B.Ed. was not granted and two units for BA.B.Ed. were given.
- 2. The Committee decided that the request of institution for granting B.Sc.B.Ed. cannot be acceded to.

Hence, the institution may be accordingly.

- 7. **NOW THEREFORE**, in exercise of the powers vested u/s 14/15 of the NCTE Act, 1993, the Western Regional Committee hereby refuse the request of **CHOUDHARI TEACHER TRAINING COLLEGE**, **PLOT No. 1003,1003/1, STREET/ROAD NH 8, SANGTEDA, KOTPUTLI, DISTRICT JAIPUR, STATE-RAJASTHAN** for grant of **B.Sc.B.Ed**. course on the grounds mentioned above.
- 8. **FURTHER**, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act. 1993 through "online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of issue of this Order. The guidelines for filing appeal may be seen on NCTE's website.
