RECOGNITION ORDER

WHEREAS, in terms of Section 14 of the NCTE Act, 1993, **DISTRICT INSTITUTE OF EDUCATION AND TRAINING HARDA, STREET/ROAD: INDORE ROAD, VILLAGE/TOWN/CITY: HARDA, POST OFFICE: HARDA, TEHSIL/TALUKA: HARDA, TOWN/CITY: HARDA, DISTRICT: HARDA 461331, MADHYA PRADESH (Code No./APP2513)** had submitted application to the Western Regional Committee of the NCTE for grant of recognition to **DIET HARDA, PLOT/KHASARA NO. 278, VILLAGE: BAGRULE, POST OFFICE: HARDA, TEHSIL/TALUKA: HANDIYA, TOWN/CITY: HARDA, DISTRICT: HARDA 461331, MADHYA PRADESH** for **D.El.Ed.** course of 2 years on **31.07.2013**.

AND WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

AND WHEREAS, the matter was placed in 265th Meeting of WRC held on 27-29 December, 2016 and the Committee decided that:- "...Consequent to the issue of LOI, the institution has submitted a list of 1 Principal and 3 Lecturers. The Lecturers do not have the required percentage at M.Ed. and the percentage of marks at the PG level is also not given. Further, the list is not approved by the competent authority. **Hence, Show Cause Notice be issued to the institution as to why the Recognition should not be refused because of the above reasons. Reply should be submitted within 30 days.**" Accordingly, Show Cause Notice was issued to the institution on 03.01.2017.

AND WHEREAS, the reply received from the institution was placed in the 268th meeting of WRC held on February 09-11, 2017 and the Committee decided that:- "...Show Cause Notice was issued to the institution for inadequacy of teaching faculty. The institution has not satisfactorily responded to the Show Cause Notice. The institution has submitted a staff list where only four faculty members have been appointed, whereas the requirement is one Principal and seven faculty members. **Hence, Recognition is refused.**" Accordingly, Refusal order was issued to the institution on 14.02.2017.

AND WHEREAS, the institution has filed an appeal NCTE, Hqrs. on 31.01.2020. The Appellate Authority vide its order dated 15.09.2020 remanded back the case to the WRC, NCTE, for necessary action.

AND WHEREAS, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit, and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee in its **317th meeting held on September 28 & 30, 2020** is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the **D.El.Ed.** programme, such as, infrastructural and instructional facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

NOW, THEREFORE, in exercise of the powers vested under **Section 15 (3) (a)** of the NCTE Act, 1993 and in accordance with the Regulations, 2014, the Competent Authority of the Western Regional Committee, NCTE hereby grants recognition to **DIET HARDA, PLOT/KHASARA NO. 278, VILLAGE: BAGRULE, POST OFFICE: HARDA, TEHSIL/TALUKA: HANDIYA, TOWN/CITY: HARDA, DISTRICT: HARDA 461331, MADHYA PRADESH** for conducting **D.El.Ed.** programme of **2 (Two) years** duration with an annual intake of **50 students (One basic unit)** from the academic session **2021-22**.

The institution shall gradually move towards becoming a composite institution as per clause 8(1) of the NCTE Regulations, 2014.

The institution shall comply with various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

The institution shall make admissions only after it obtains affiliation from the examining body in term of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

The institution shall ensure that the required number of academic staff for conducting the course is always in position.

The recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, State Government etc. as applicable.

The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with annual statement of accounts duly audited by a Chartered Accountant.

The institution shall fill the GIS information on the NCTE website within one month from the date of this order.

The institution shall maintain & update its web-site as per provisions of NCTE Regulations and always display the following as mandatory disclosure:-

- a) Sanctioned programmes along with annual intake in the institution:
- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c) Name of faculty members who left or joined during the last, quarter:
- d) Names of Students admitted during the current session along with qualification, percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e) Fee charged from students;
- f) Available infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information. if it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
