Whereas, in terms of Section 14(1) of the NCTE Act, 1993, Gyandhara Shiksha Samiti, Plot/Khasra No. – 28/2 and others,Street/Road-Loing Road Near DPS, Village- Kotrapali, Post Office-Jurda, Tehsil/Taluka- Raigarh, District- Raigarh, Chhattisgarh - 496001 (WRCAPP3050) had submitted on 28.06.2015 the application to the Western Regional Committee of the NCTE for grant of recognition to JVG College of Education, Plot/Khasra No. – 28/2 and others, Village-Kotrapali,Post Office- Jurda, Raigarh, Chhattisgarh - 496001 for D.El.Ed. And whereas, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit, and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee in its 273rd meeting held on 18th – 19th April, 2017 is satisfied that the institution/society fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the D.El.Ed. programme, such as, infrastructural and instructional facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

- a) Sanctioned programmes along with annual intake in the institution:
- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c) Name of faculty members who left or joined during the last, quarter:
- d) Names of Students admitted during the current session along with qualification, percentage of marks
- e) in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- f) Fee charged from students;
- g) Available infrastructural facilities;
- h) Facilities added during the last quarter;
- i) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- j) The affidavit with enclosure submitted along with application.
- k) The institution shall be free to post additional relevant information. if it so desires.
- I) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution contravenes the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.
