Withdrawal Order

WHEREAS, recognition was granted to the institution, namely, SHRI DWARIKA PRASAD YADAV SHIKSHA MAHAVIDYALAYA, BRIJ COLONY, SRIONJ, VIDISHA, MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting B.ED. course (100 Intake) vide order dated 26.09.2005.

2. AND WHEREAS, the letter for AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 19.01.2015 and the reply was received on 28-01-2015.

3. AND WHEREAS, Revised Recognition order was issued to the institution for two basic units of (50 students each) on 31.05.2015.

4. AND, WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."

5. AND, WHEREAS, a Show cause notice was issued to the institution on 08.09.2016 for not submitting the following documents in compliance of Regulation 2014 mentioned in the revised order:

- 1) Staff Profile for the session 2015-16 duly approved by the affiliating body.
- 2) Originally notarized CLU/NEC/BP and Building Completion Certificate.

6. AND WHEREAS, the reply of show cause notice was submitted by the institution on 27.10.2016.

7. AND WHEREAS, the matter was placed in 285th Meeting of WRC held on December 19-21, 2017 and the Committee decided that "...In response to the Show Cause Notice dated 08.09.2016, the institution vide letter dated 27.10.2016 has submitted photocopy of list of 8 faculty members, which is sufficient for only one unit of B.Ed. course.

The institution is required to submit list of faculty in the NCTE format duly approved by the Registrar for the current academic year in original.

Building Completion Certificate signed by a Govt. Engineer and FDRs of Rs.12.00 lakhs (in joint name) should be submitted in original.

Compliance should be submitted by the institution within one month, failing which Recognition will be withdrawn."

8. AND, WHEREAS, a Show cause notice was issued to the institution on 29.12.2017 and reply was submitted by the institution on 23.01.2018.

9. AND WHEREAS, the matter was placed in 290th Meeting of WRC held on March 21-23, 2018 and the Committee decided that "...Consequent to the issue of Show Cause Notice, compliance letter was issued to the institution on 29.12.2017 and reply received on 23.01.2018. The institution was asked to submit the staff profile in original which it has not done.

Further, lecturers at S.No.4 & 6 are not qualified, since they do not have M.Ed. It reduces the staff profile to 1+5 which is not even sufficient for one unit.

Inspite of many opportunities, institution has not submitted an adequate staff profile.

Hence, Recognition is withdrawn from the end of the next academic session."

10. AND, WHEREAS, the withdrawal order was issued to the institution on 28.03.2018.

11. AND, WHEREAS, the institution filed an Appeal to the Council On 25.07.2018 and the Council vide its order dated 27.03.2019 confirms Order of Appeal. The institution filed an W.P. No. 4498/2019 & CM APPLs.20045/2019.

12. AND WHEREAS, the matter was placed in 307th Meeting held on 30th-31st May 2019 of WRC and the Committee decided that "...In view of the direction of the Hon'ble High Court of Delhi in W.P.(C) & CM APPL 20045/2019 order dated 29/04/2019 and the committee considered the reply of the institution dated 11/05/2019 and observed that :

- The institution has not submitted FDRs Rs. 7+5 lacs towards Reserve Fund & Endowment Fund in original.
- The staff profile does not match with the letter of approval dated 5/12/2015 and 02/03/2019 issued by affiliating body and staff list approved by the Registrar.

The institution is required to submit latest staff list approved by the affiliating body alongwith the letter of granting approval of staff.

Hence, the committee decided to confer last opportunity to the institution to submit the above documents in original within 30 days failing which recognition will be withdrawn under section 17 of NCTE Act, 1993."

13. AND WHEREAS, the show cause notice was issued to the institution on 06.06.2019 and reply was submitted by the institution on 05.07.2019.

14. AND WHEREAS, the matter was placed in 314th Meeting held on July 13th to 15th & 22nd 2020 of WRC and the Committee decided that "...This is a RPRO case remanded back by the Court.

The Committee noted that the Show Cause notice was issued to the institution on 06.06.2019 and reply received on 05.07.2019.

- After examination of the documents, it is observed that the faculty mentioned at Sr. No. 02,03,05,06,07,08 in the staff profile are not qualified as they do not have NET/ Phd as per amended Regulations dated 09.06.2017.
- Lecturer for Physical Education, Fine Arts and Performing Arts have not been appointed.

In view of the above, the WRC decided that the decision of WRC taken in 290th meeting for withdrawal of recognition stands."

8. NOW THEREFORE, The withdrawal order of the recognition of the institution **SHRI DWARIKA PRASAD YADAV SHIKSHA MAHAVIDYALAYA, BRIJ COLONY, SRIONJ, VIDISHA, MADHYA PRADESH** of B.Ed. course dt. 28.03.2018 stands.

9. Further, if the institution is not satisfied by the order, they can prefer an appeal to National Council for Teacher Education, G-7, Sector-10, Dwarka, New Delhi-110075 **online** www.ncte.gov.in against this order under Section 18 of the NCTE Act, 1993 within 60 days of the issue of this order. The guidelines for filing the appeal may be seen on NCTE website
