ORDER OF CLOSURE

WHEREAS, WRC, NCTE has granted the recognition/permission under section 14(3)(a)/15(3)(a) of the NCTE Act 1993 to the institution namely, SMT. YASHODA BHOYAR ADHYAPAK MAHAVIDYALAYA, V.P.O CHAPEGADI, TA. KUIH, NAGPUR for conducting the B.ED. course of one-year(s) duration with an annual intake of 100 students vide WRC order no. WRC/5-6/88/2006/ dated: 15.09.2006.

2. AND WHEREAS, the Society/Trust/institution SHRI SADASHIVRAO PATIL SHIKSHAN, SANSTHA KAMPTEE 50, THE MALL ROAD KAMPTEE CANTT., KAMPTEE-441002 DIST- NAGPUR MAHARASHTRA has submitted a request for closing the B.ED. course vide its letter dated: 31.01.2019.

3. AND WHEREAS, the matter was placed before WRC in its 314th meeting held on 13th - 15th and 22nd JULY 2020, and the Committee decided as under:-

"On perusal of the file of the institution and request for the closure of the programme by the institute / Management, the Committee resolved to accede to the request of the management / institution and decided that the recognition granted to the institution be withdrawn from the end of the academic session and withdrawal order be issued.

Further, the FDRs towards Endowment and Reserve fund, available with NCTE, may be returned permitted to be encashed only after submission of the following documents :-


- *Resolution of the Society for closure of the programme.*
- *NOC from the affiliating body as well as from the State Government for closure of the programme."*

Now therefore, as per the decision of WRC, in exercise of the powers vested u/s 17 (1) of the NCTE Act, 1993 as amended time to time the Western Regional Committee hereby withdraws recognition of SHRI SADASHIVRAO PATIL SHIKSHAN, SANSTHA KAMPTEE 50, THE MALL ROAD KAMPTEE CANTT., KAMPTEE-441002 DIST- NAGPUR MAHARASHTRA granted for conducting B.ED. course acceding to the request for closure made by the Society/Trust/Institution from the end of the academic session next following the date of communication of this order.

6. Further, the institution is requested to send the documents as required by WRC, in order to enable WRC to send the FDRs of the institution, if any, available with WRC-NCTE.
