RESTORATION ORDER

WHEREAS, WRC-NCTE had granted permission to the institution namely **DNYANDEEP EDUCATION SOCIETY, ABHAY SANKUL, POPHALE GIN COMPOUND, SATANA ROAD, MALEGAON, NASIK-423203 MAHARASHTRA** vide order No. WRC/5-6/101st/2008/27775 dated: **28.01.2008** for conducting B.Ed. course with an annual intake of **100** students.

2. AND, WHEREAS, the revised recognition Order was issued to the institution namely **DNYANDEEP EDUCATION SOCIETY, ABHAY SANKUL, POPHALE GIN COMPOUND, SATANA ROAD, MALEGAON, NASIK- 423203, MAHARASHTRA** vide order No. WRC/APW02741/123340/2015/141105-112 dt. 31.05.2015 for B.Ed. course of two years duration with an annual intake of 100 students (two basic unit of 50 students).

3. AND WHEREAS as per decision of WRC in **255th meeting**, Show Cause Notice was issued to the institution on 27.02.2017 and the reply of receipt vide letter dt. 11.04.2017 has requested the this office to reduce the intake of 2 unit (100 students) to 1 unit (50 students).

4. AND WHEREAS, the matter was placed in **259th Meeting** held on September 21 - 23, 2016 of WRC and the Committee decided that "...Institution which have requested for reducing intake may be permitted."

5. AND WHEREAS, the reduced order was issued to the institution vide dated 08/05/2017 and compliance for one unit has not been submitted by the institution.

6. AND WHEREAS, the letter for seeking Clarification/Conveying was issued to the institution on 06.02.2018 as per the decision of WRC in **287th meeting** and the reply was received on 07.03.2018.

7. AND WHEREAS, the reply was placed before WRC in its **290th Meeting** held on March 21 - 23, 2018 of WRC and the Committee decided that "...The case file was seen. In response to the compliance letter dated 06.02.2018, the institution replied on 07.03.2018. The institution was asked to submit staff list of 1+7 faculty members approved by the University in original. The institution was also asked to submit Building Completion Certificate and FDRs for Rs.12.00 lakhs.

The institution has submitted a photocopy of staff profile of 1+6 excluding librarian. Building Completion Certificate is signed by a private architect and FDRs have not been submitted.

Hence, Recognition is withdrawn from tne end of the next academic session."

Accordingly, the Withdrawal Order was issued to the institution on 10.04.2018.

8. AND WHEREAS, the institution filed an appeal to the Appellate Authority Hqrs. and the Appellate Authority vide Order dated 12th September 2018 remanded back the case to WRC with a direction to consider the appellant's letter 05/04/2018 and take further action as per the NCTE Regulations, 2014.

9. AND WHEREAS, the institution submitted the compliance in pursuance of appeal order, which was considered by WRC in its **299th meeting** held on October 30 - 31, and November 01, 2018 and the Committee decided to issue Show Cause Notice to the institution on certain points.

10. AND WHEREAS, the Show Cause Notice was issued to the institution on 02/11/2018 and the reply was received on 30/11/2018.



11. AND WHEREAS, the reply was considered in 310th Meeting of WRC held on August 19th – 21st, 2019 and the Committee decided that "... *The Show Cause Notice was issued to the institution vide letter dated 02/11/2018 and reply received on 29/11/2018.*

On perusal of the reply of the institution the committee observed that:

- *The institution has submitted staff profile of 1+7 (excluding librarian) faculty members duly approved by the affiliating University.*
- *Staff at Sr. No. 3,5,6,7 & 8 are not qualified (not having NET/ Ph.D) as per NCTE Amended Regulations 9/6/2017.*
- *Original FDRs of Rs. 3+5 lakhs. in Joint operation are not submitted.*

Hence, the committee decided that the withdrawal order dated 10/04/2018 stands.

Accordingly, the decision of WRC was intimated to the institution vide order 30.08.2019.

12. AND WHEREAS, the institution filed Court case in the Hon'ble High Court of Delhi vide WP No. 9930/2019 & CM APPL No: 41106/2019 and the order of the Hon'ble High Court in above Writ Petition was considered by WRC in its **312th Meeting held on January 27th-29th, 2020** and the Committee decided that "...

The Committee studied the decision of the Hon'ble High Court in the W.P. No. 9930/2019 & CM No. 41106/2019. The Committee decided that the representative of the institution be given personal hearing in the next meeting of WRC. The date of the personal hearing will be intimated later.

The representative alongwith all the requisite documents as mentioned in Court Order be remain present.

Accordingly, the Communication letter was issued to the institution on 10.02.2020.

13. AND WHEREAS, The matter was considered by WRC in its **313th meeting**, wherein the committee decided as under:-

As per the decision of WRC in its 312th meeting in compliance of the Court directions, the representatives of the institution appeared before WRC for personal hearing on 26/02/2020. It is decided after the discussion that the representative of the institution will submit the required documents today itself.

14. **AND WHEREAS**, the institution has submitted the reply on dt. 26.02.2020 to the Communication letter dated 10.02.2020. The matter was considered by WRC in its **315th meeting** held on 10th to 11th and 14th August 2020 & **316th meeting** held on 27th – 28th August 2020 & 4th September 2020 wherein the committee decided as under: -

"...This is a RPRO case and same was remanded back through Court with a direction to call the petitioner for personal hearing.

The personal hearing of the institution was held on 26th February 2020, wherein it was decided that the representative of the institution will submit the required documents today itself. The institution submitted the documents on 26th Feb 2020.

The WRC examined the documents submitted by the institution and observed that the institution has complied with the requirements laid down under NCTE Regulations and decided

that the recognition granted to the institution for B.Ed course with an annual intake of 50 students (one Units) be restored from the date of issue of order."

15. NOW THEREFORE, the recognition of **DYANDEEP EDUCATION SOCIETY, ABHAY SANKUL, POPHALE GIN COMPOUND, SATANA ROAD, MALEGAON, NASIK – 423203, MAHARASHTRA** for conducting B.Ed. course with an annual intake of 50 students (one basic units of 50 students) is hereby restored from the date of issue of order.
