WHEREAS, recognition was granted to the institution, namely, SARDAR VALLABH BHAI PATEL SHIKSHA MAHAVIDHYALAYA, KHASRA NO.- 183/3, 183/4, 184/6, NIWALI ROAD, SHIV DHAM , VILL-SILDAD, BARWANI, MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting B.ED. course (100 Intake) vide order dated 31.08.2006.

- 2. AND WHEREAS, the letter for AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 19.01.2015 and the reply was received on 16-01-2015.
- 3. AND WHEREAS, Revised Recognition order was issued to the institution for two basic units of (50 students each) on 27.05.2015.
- 4. AND, WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "... The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."
- 5. AND, WHEREAS, a Show cause notice was issued to the institution on 19.09.2016 for not submitting the following documents in compliance of Regulation 2014 mentioned in the revised order:
  - 1) Originally notarized Building Plan (readable).
- 6. AND WHEREAS, the reply of show cause notice was submitted by the institution on 29-09-2016.
- 7. AND WHEREAS, the matter was placed in 305th Meeting of WRC held on April 15th-16th, 2019 and the Committee decided that "... The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by WRC and the following observations were made: -

The revised recognition order was issued to the institution on 27/05/2015. The Show Cause Notice was issued to the institution 19/09/2016. The institution has submitted reply of Show Cause Notice 27/09/2016 & 07/03/2019.

On perusal of the reply of the institution it is observed that the institution has not submitted the following documents:

The institution has not submitted a letter of approval of faculty of affiliating body. along with detailed staff profile approved by competent authority of the University as per NCTE amendment Regulations 09/06/ 2017.

- The institution has not submitted building plan approved by the competent authority mentioning name of university, name of course, khasra No./ Plot number, total land area, total built up area and earmarked area for each course being run in the same premises.
- The institution website is functional but contents not as per clause 7(14)(i) of NCTE Regulations, 2014.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

- 8. AND, WHEREAS, the withdrawal order was issued to the institution on 24.04.2019. The institution filed an W.P. no. 4969/2019 & CM APPL 22098/2019 in the Hon'ble High Court of Delhi at New Delhi, the Court Order dated 08.05.2019 received in WRO on 21.05.2019.
- 9. AND WHEREAS, the matter was placed in 307<sup>th</sup> Meeting held on May 30<sup>th</sup>-31<sup>st</sup>, 2019 of WRC and the Committee decided that "...In view of the direction of the Hon'ble High Court of Delhi in W.P.(C)4969/2019 & CM APPL 22098/2019 order dated 08/05/2019 withdrawal order stayed at point No. 12, therefore, website be updated accordingly, as observed by the Hon'ble High Court to issue Show Cause Notice to the institution on the points on which the recognition stands withdrawn.
  - The institution has not submitted a letter of approval of faculty of affiliating body. along with detailed staff profile approved by competent authority of the University as per NCTE amendment Regulations 09/06/ 2017.
  - The institution has not submitted building plan approved by the competent authority mentioning name of university, name of course, khasra No./ Plot number, total land area, total built up area and earmarked area for each course being run in the same premises.
  - The institution website is functional but contents not as per clause 7(14)(i) of NCTE Regulations, 2014.

Hence the committee decided to issue Show Cause Notice under section 17(1) of NCTE Act, 1993 to the institution to submit the above within 30 days.

### Counter Affidavit to be filed in Hon'ble High Court accordingly."

- 10. AND, WHEREAS, the show cause notice was issued to the institution on 10.06.2019 and reply was submitted by the institution on 04.07.2019 & 18-09-2019.
- 11. AND WHEREAS, the matter was placed in  $314^{th}$  Meeting held on July  $13^{th}$  to  $15^{th}$  &  $22^{nd}$ , 2020 of WRC and the Committee decided that "...This is a RPRO case remanded back by the Court

Revised recognition order was issued on 27.05.2015 for two units of B.Ed. course and reply received on 04.07.2019 and 18.09.2019.

After examination of the documents, it is found that the all required documents are found to be satisfactory.

In view of the above, the Committee decided that the recognition granted to the institution be permitted to continue the existing B.Ed. course with two units."
