ORDER

- 2. **AND WHEREAS**, additional intake 100 students (2 unit) D.El.Ed (Marathi medium) was permitted by WRC vide order dated 24th December 2006, as per the decision of WRC in its 92nd meeting.
- 3. AND WHEREAS, LOKMANYA TILAK JANKALYAN SHIKSHAN SANSTHA NAGPUR has submitted a request for close down D.El.Ed. (One Unit) Marathi medium course vide its letter dated: 16.11.2018.
- 4. AND WHEREAS, the matter was placed before WRC in its 317th meeting held on 28th 30th September, 2020, and the Committee decided as under:-

This is an existing institution running the D.EI.Ed course for three units.

The institution vide request dated 16th Nov 2018 has requested for closure of one unit of Marathi Medium and requested that the institution be permitted to run two units (One Unit of Marathi and One unit of English Medium).

The WRC considered the matter and detail and decided that the request of the institution for withdrawal of one unit of D.El.Ed course be acceded to.

- Now therefore, as per the decision of WRC, in exercise of the powers vested u/s 17 (1) of the NCTE Act, 1993 as amended time to time the Western Regional Committee hereby reduces the intake of PALLAVI COLLEGE OF DIPLOMA IN EDUCATOIN, TRIMURTI CHOWK, NEW NANDANWAN, NAGPUR-440009 for conducting D.El.ED. course to 100 students (2 units), acceding to the request made by the Society.
- 6. The institution may prefer an Appeal u/s 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of issue of this order. The guidelines for filing appeal are available on the NCTE website.
