#### **REVISED RESTORATION ORDER**

WHEREAS, recognition was granted to the institution namely, **HICT SHIKSHA MAHAVIDYALAYA**, **RUN BY- POORVI MAHILA AVAM BAL VIKAS KALYAN SAMITI, TANSEN ROAD, GWALIOR, MADHYA PRADESH** under section 14(3)(a) of NCTE Act, 1993 for conducting M.ED. course for 25 students vide order No. WRC/5-6/109<sup>th</sup>/2008/45500-45505 dated 29.10.2008.

AND WHEREAS, the Shifting premises order was issued to the institution namely HICT SHIKSHA MAHAVIDHYALAYA, GRAM ADUPURA, DABRA ROAD, GWALIOR, MADHYA PRADESH vide order No. WRC /APW04607/225053(Shifting)/179 $^{\rm th}$ /2013/101542-101548 dt. 18.03.2013.

AND WHEREAS, the revised recognition order was issued to **HICT SHIKSHA MAHAVIDHYALAYA**, **SURVEY NO. 514, PATWARI HALKA NO.45, GRAM ADUPURA, DABRA ROAD, GWALIOR, MADHYA PRADESH** vide order no. WRC/APW04607/225053/{M.P.}/2015/143990/99/4004/08/21/26/30/36 dt. 31.05.2015 for M.Ed. Programme of two years duration with an annual intake of 50 students (One unit) from the academic session 2015-16.

AND WHEREAS, the matter was placed in 255<sup>th</sup> Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."

AND WHEREAS, a Show Cause Notice was issued to the institution on 06.01.2017 for not submitting the following documents in compliance of Regulation 2014 mentioned in the revised order:

1) Staff Profile for the session 2015-16 duly approved by the affiliating body.

2) Originally notarized CLU/NEC/BP and Building Completion Certificate.

AND WHEREAS, the reply of Show Cause Notice was submitted by the institution on 18.01.2017.

AND WHEREAS, the matter was placed in 296<sup>th</sup> Meeting of WRC held on August 28-29, 2018 and the Committee decided that:- "...Show Cause Notice was issued to the institution on 06.01.2017. The institution replied vide letter dated 18.01.2017. It has submitted an approved list of faculty members. The requirement is two Professors whereas the institution has appointed only one. Further, Assistant Professor at S.No.4 does not have PG degree. It has also not submitted Building Completion Certificate and additional FDR for Rs.4.00 lakhs. Hence, compliance letter be issued to the institution. Reply should be submitted within one month, failing which Recognition will be withdrawn."

AND WHEREAS, the Clarification letter was issued to the institution on 06.09.2018.

AND WHEREAS, the institution has submitted reply vide letter dt. 02.10.2018 received in WRO on 05.10.2018.

AND WHEREAS, the matter was placed in 311<sup>th</sup> Meeting of WRC held on September 25-27, 2019 and the Committee decided that:-".... The SCN was issued to the institution on 6/1/2017. The compliance letter was issued to the institution on 06/01/20118. The institution has submitted reply on 02/10/2018.

The summary of the case reveals that the reply was not submitted within the stipulated time of 30 days as per the Show Cause Notice.

On perusal of the reply of the institution the committee observed that:

- The institution has not submitted a letter of granting approval by the Affiliating University as per the NCTE Regulations, 2014.
- The institution has submitted staff profile singed by Registrar, Jiwaji University, Gwalior without referring to the academic session for which it was approved.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for M.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

AND WHEREAS, the Withdrawal order was issued to the institution on 10.10.2019.

AND WHEREAS, a letter received from the institution on 16.12.2019 alongwith enclosed Court Order of Hon'ble High Court of Delhi at New Delhi, and the institution has filed W.P. (C) 12169/2019 on 19.11.2019.

AND WHEREAS, the matter was placed in 312<sup>th</sup> Meeting held on January 27-29, 2020 of WRC and the Committee decided that:- "The Committee studied the decision of the Hon'ble High Court in the W.P. No. 12169/2019. The Committee decided that the representative of the institution be given personal hearing in the next meeting of WRC. The date of the personal hearing will be intimated later. The representative alongwith all the requisite documents be remain present."

AND WHEREAS, Communication letter was issued to the institution on 12.02.2020.

AND WHEREAS, the matter was placed in 31.3<sup>th</sup> Meeting held on February 25-27, 2020 of WRC and the Committee decided that:- "As per the decision of WRC in its 312th meeting in compliance of the Court directions, the representatives of the institution appeared before WRC for personal hearing on 26/02/2020. It is decided after the discussion that the representative of the institution will submit the required documents today itself." Accordingly, the institution has submitted reply dt. 27.02.2020.

AND WHEREAS, the matter was placed in 315<sup>th</sup> Meeting held on August 10-11 & 14, 2020 of WRC and the Committee decided that:- "This is a RPRO case and same was remanded back through Court with a direction to call the petitioner for personal hearing. The personal hearing of the institution was held on 26<sup>th</sup> February 2020, wherein it was decided that the representative of the institution will submit the required documents today itself. The institution submitted the documents on 27<sup>th</sup> Feb 2020.

The WRC examined the documents submitted by the institution and observed that the institution has complied with the requirements laid down under NCTE Regulations and decided that the recognition granted to the institution for M.Ed course with an annual intake of 50 students (One Unit) be restored."

AND WHEREAS, the matter was placed in 316th Meeting held on August 27-28 & 04 September 2020 of WRC and the Committee decided that:- "This is a RPRO case and same was remanded back through Court with a direction to call the petitioner for personal hearing. The personal hearing of the institution was held on 26th February 2020, wherein it was decided that the representative of the institution will submit the required documents today itself. The institution submitted the documents on  $27^{th}$  Feb 2020. The WRC examined the documents submitted by the institution and observed that the institution has complied with the requirements laid down under NCTE Regulations and decided that the recognition granted to the institution for M.Ed course with an annual intake of 50 students (One Unit) be restored from the date of issue of order."

NOW THEREFORE, the recognition of HICT SHIKSHA MAHAVIDHYALAYA, SURVEY NO. 514, PATWARI HALKA NO.45, GRAM ADUPURA, DABRA ROAD, GWALIOR, MADHYA PRADESH be Restored for conducting M.Ed. course of two years with an annual intake of 50 students (One unit) is restored from the date of issue of this order.
