RESTORATION ORDER

WHEREAS, recognition was granted to the institution namely, SHRI RAWATPURA SARKAR COLLEGE OF EDUCATION, SHRANGARWAN, SHRI RAWATPURA SARKAR ASHRAM, NEAR PWD REST HOUSE, SATNA ROAD, CHITRAKOOT, 485331 MADHYA PRADESH under section 15(3)(a) of NCTE Act, 1993 for conducting B.ED. course of one year duration with an annual intake of 100 students vide order No. WRC/5-6/102/2008/29950-29956 dated 01.03.2008.

AND WHEREAS, the revised recognition order was issued to SHRI RAWATPURA SARKAR COLLEGE OF EDUCATION, SHRANGARWAN, SHRI RAWATPURA SARKAR ASHRAM, NEAR PWD REST HOUSE, SATNA ROAD, CHITRAKOOT, 485331 MADHYA PRADESH vide order no. WRC/APW04903/223545/2015/149253-9260 dt. 31.05.2015 for B.Ed. Programme of two years duration with an annual intake of 100 students (two unit) from the academic session 2015-16.

AND WHEREAS, the institution has not submitted Compliance of revised recognition order ${\rm dt.}$ 31.05.2015.

AND WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."

AND WHEREAS, a Show Cause Notice was issued to the institution on 26.05.2017 for not submitting the following documents in compliance of Regulation 2014 mentioned in the revised order:

- 1) Original Staff Profile (1-Principal/HOD+15-Faculties) for the session 2015-16 duly approved by the affiliating body.
- 2) Originally notarized (not xerox) CLU, NEC, Building Plan and Building Completion Certificate in Prescribed format.

AND WHEREAS, the reply of Show Cause Notice not submitted by the institution.

AND WHEREAS, the matter was placed in 310th Meeting of WRC held on 19th to 21st August 2019 and the Committee decided that:- "The Show Cause Notice was issued to the institution vide letter dated 26/05/2017. The summary of the case submitted reveals that the institution has not submitted reply of the Show Cause Notice. Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

AND WHEREAS, the Withdrawal order was issued to the institution on 05.09.2019.

AND WHEREAS, the institution has filed an appeal NCTE, Hqrs. on 23.01.2020. The Appellate Authority vide its order dated 19.03.2020 remanded back the case to the WRC, NCTE, for necessary action.

AND WHEREAS, the institution has submitted reply vide letter dt. 02.04.2020 received in WRO on 01.07.2020.

AND WHEREAS, the institution has filed W.P. (C) 5199/2020 Court order of Hon'ble High Court of Delhi at New Delhi, and court order dated 13.08.2020.
