### **RESTORATION ORDER**

WHEREAS, recognition was granted to the institution namely, VIDYASAGAR COLLEGE, VILLAGE- BHICHOLI MARDANA, INDORE, MADHYA PRADESH under section 15(3)(a) of NCTE Act, 1993 for conducting M.ED. course of one (1) year for 25 students vide order No. WRC/5-6/ 100th/2007/26096-26102 dated 10.01.2008 and enhancement of intake was permitted vide order No. WRC/APW05029/225062/140<sup>th</sup>/2010/73584-73590 dated 12.01.2011 from 25 to 35 seats.

AND WHEREAS, the revised recognition order was issued to VIDYASAGAR COLLEGE, VILLAGE-BHICHOLI MARDANA, INDORE, MADHYA PRADESH vide order no. WRC/APW05029/225062/{M.P.}/ 2015/135189 dt. 16.05.2015 for M.Ed. Programme of two (2) years duration with an annual intake of 50 students (One unit) from the academic session 2015-16.

AND WHEREAS, the institution has not submitted Compliance of revised recognition order dt. 16.05.2015.

AND WHEREAS, the matter was placed in 255th Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."

AND WHEREAS, a Show Cause Notice was issued to the institution on 13.01.2017 for not submitting the following documents in compliance of Regulation 2014 mentioned in the revised order:

- 1) Staff Profile for the session 2015-16 duly approved by the affiliating body.
- 2) Originally notarized CLU/NEC/BP and Building Completion Certificate.

AND WHEREAS, the institution has not submitted reply of Show Cause Notice dt. 13.01.2017.

AND WHEREAS, the application for shifting premises dt. 23.01.2017 received in WRO from VIDYASAGAR COLLEGE, VILLAGE- BHICHOLI MARDANA, INDORE, MADHYA PRADESH to VIDYASAGAR COLLEGE, SURVEY NO. 199/2, 200/1/2, 200/2/1/2 & 201/2, VILLAGE- HINGONIYA, TEHSIL/ DISTRICT- INDORE, MADHYA PRADESH.

AND WHEREAS, the matter was placed in 283th Meeting of WRC held on 14-15 November 2017 and the Committee decided that:- "This is a case of shifting. The institution needs to submit the following documents before VT can be constituted:-

- (a) Latest premium paid receipt of CLU;
- (b) Building Completion Certificate approved from a Govt. Engineer; and
- (c) FDRs for Rs.12.00 lakhs in joint name.

### Hence, Show Cause Notice be issued to the institution."

AND WHEREAS, Show Cause Notice was issued to the institution dt. 27.11.2017 and reply received on 19.12.2017.

AND WHEREAS, the matter was placed in 309th Meeting of WRC held on 23 to 26 July 2019 and the Committee decided that:- "...The Show Cause Notice was issued to the institution vide letter dated 13/01/2017. The reply of the Show Cause Notice of the institution has not been received .

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for M.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

AND WHEREAS, the Withdrawal order was issued to the institution on 09.08.2019.

AND WHEREAS, the institution has filed an appeal NCTE, Hqrs. on 20.08.2019. The Appellate Authority vide its order dated 05.12.2020 remanded back the case to the WRC, NCTE, for necessary action.

AND WHEREAS, the matter was placed in 313<sup>th</sup> Meeting of WRC held on 25-27 February 2020 and the Committee decided that:- "The Committee considered the matter keeping in view the directions of the Appellate Authority order dated 05.12.2019 and decided that Show Cause Notice u/s 17 of the NCTE Act be issued on the institution on following grounds:-

- (i) The institution is required to submit BCC issued by the competent Govt. authority in the name of the institution in original.
- (ii) FDR of Rs. 5.00 and Rs. 7.00 lakhs not submitted.

In view of the above, a Show Cause Notice be issued u/s 17 of the NCTE Act to the institution to reply within 30 days."

AND WHEREAS, Show Cause Notice was issued to the institution dt. 06.03.2020 and reply received on 06.08.2020.

AND WHEREAS, a letter received from the institution by email vide order dt. 04/09/2020 received in section on 07.09.2020 alongwith Hon'ble High Court Order W.P. (C) No. 5626/2020 and Court order dt. 25.08.2020.

AND WHEREAS, a letter was issued to the Higher Education Department, to add name of the institution in recognition list of the NCTE WRC vide dated 10.09.2020.

AND WHEREAS, the matter was placed in 317<sup>th</sup> Meeting of WRC held on 28 & 30 September, 2020 and the Committee decided that:-" The Committee considered the matter keeping in view the directions of the Hon'ble Court in W.P. No. 5626/2020 and noted that as per the direction of the Hon'ble Court, the name of this institution has been updated on the website of NCTE and also the letter to the State Government has been sent.

The Committee considered the reply of the institution dated 06.08.2020 in response to Show Cause Notice dated 06.03.2020 and decided that the institution has complied with all the requirements laid down in NCTE Regulations, hence, recognition of the institution be restored for M.Ed course with an annual intake of one unit from the date of issue of the order. "

NOW THEREFORE, the recognition of VIDYASAGAR COLLEGE, VILLAGE- BHICHOLI MARDANA, INDORE, MADHYA PRADESH is Restored from the date of this order for conducting M.Ed. course of two years with an annual intake of 50 students (One unit).
