Show Cause Notice under section 17 (1) NCTE Regulations, 1993

Whereas, the recognition was granted to the institution namely, Gram Meduka Krishi Shikshan Samiti, College Of Education, Village-Meduka, Post-Darri, Tehsil-Pendra Road, Distirct-Bilaspur, Chhattisgarh-495117, for M.Ed. Course Vide order no WRC/5-6/103rd/2008/34063-34068 dt. 10.05.2008.

Whereas, existing annual intake of M.Ed. course was enhance from 25 to 35 students per year WRC order no. WRC/APW05868/725019/140 th /2010/71322-71326 dt. 20.10.2010.

And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 College Of Education Meduka, Pedra Road, (Run by- Gram Meduka Krishi Shikshan Samiti, Meduka) Chhattisgarh, M.Ed. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution.

And whereas, after the receipt of affidavit dt. 12.01.2015 from the institution, a revised recognition order no. WRC/APW05868/725019/2015/9104 dt. 02.07.2015 was issued to the institution for conducting M.Ed. course of two years duration with an annual intake of 50 seats (one basic units of 50 students each) from the session 2015-16.

And whereas, the institution vide revised recognition order dt. 02.07.2015 was directed to submit the followings documents in compliance of the NCTE Regulations, 2014:-

- 1. List of teaching staff, duly approved by the affiliating body, appointed by the institution for each course.
- 2. Proof of maintaining the Endowment fund and Reserve fund as per NCTE Regulations, 2014.
- 3. A duly notarized building completion certificate (BCC) issued by the competent authority.

And whereas, the institution vide letter no. 210, dt. 30.10.2015 & 3211/Acad./2015 dt. 29.10.2015 has submitted the documents in response to Revised Recognition Order dt. 02.07.2015.

And whereas, reply dt. 29.10.2015 & 30.10.2015 submitted by the institution was placed before the WRC in its 291^{st} meeting held on April $26^{\text{th}} - 27^{\text{th}}$, 2018 and the Committee decided as follows :-

"The case file was seen. In response to the Revised Recognition order dated 02.07.2015, the institution vide reply dated 30.10.2015 & 29.10.2015 submitted a staff profile of two Professors, two Associate Professors and six Assistant Professors. However, faculty at S.No.3 does not have M.Ed. and PG. Further post at S.No.4 is not mentioned.

The institution should submit approved list of two Professors, two Associate Professorsand six Assistant Professors (as per Appendix-V of NCTE Regulations, 2014) in original.

Secondly, Building Completion Certificate issued by a Government Engineer not submitted in original.

Hence, Show Cause Notice be issued as to why recognition should not be withdrawn. Reply should be submitted within one month."

Therefore, in compliance of the decision of the WRC this Show Cause Notice is issued u/s 17 (1) of NCTE Act, 1993 with the direction to submit your written representation with in a period of 30 days from the date of dispatch of this notice.

However, if your written representation is not received within 30 days, it will be presumed that you have nothing to say, and in that event the WRC shall be free to take its decision u/s 17 Act, 1993 of NCTE.
