ORDER OF CLOSURE

WHEREAS, WRC, NCTE has granted the recognition/permission under section 14(3)(a)/15(3)(a) of the NCTE Act 1993 to the institution namely, **SHIKSHAN MAHAVIDYALAYA, KATOL, DISTT. NAGPUR** for conducting the **B.ED.** course of **one-year(s)** duration with an annual intake of **80 students** vide WRC order no. WRC/5-6/21/2000, dated: **05.10.2000**.

2. AND WHEREAS, the Society/Trust/institution **SHIKSHAN PRASARAK MANDAL, DHANTOLI, PO KATOL, DIST.-NAGPUR, MAHARASHTRA-441302**, has submitted a request for closing the **B.ED.** course vide its letter dated: **21.11.2019**.

3. AND WHEREAS, the matter was placed before WRC in its **314th meeting held on 13th -15th & 22nd JULY 2020**, and the Committee decided as under:-

"On perusal of the file of the institution and request for the closure of the programme by the institute / Management, the Committee resolved to accede to the request of the management / institution and decided that the recognition granted to the institution be withdrawn from the end of the academic session and withdrawal order be issued.

Further, the FDRs towards Endowment and Reserve fund, available with NCTE, may be returned / permitted to be encashed by the institution / society."

4. Now therefore, as per the decision of WRC, in exercise of the powers vested u/s 17 (1) of the NCTE Act, 1993 as amended time to time the Western Regional Committee hereby **withdraws recognition** of **SHIKSHAN MAHAVIDYALAYA, DHANTOLI, PO KATOL, DIST.- NAGPUR, MAHARASHTRA-441302** granted for conducting **B.ED. course** acceding to the request for closure made by the Society/Trust/Institution from the end of the academic session next following the date of communication of this order.

5. As per the NCTE records, the FDR's already sent to the institution on dated 06.08.2015.

6. The institution may prefer an Appeal u/s 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of issue of this order. The guidelines for filing appeal are available on the NCTE website.
