WITHDRAWAL ORDER

Whereas, the WRC had granted the recognition to Kamla Nehru College, Run by Kamla Nehru Mahavidhyalaya Samiti, Khasra No. 947/1, Rani Road, District-Korba, Chhattisgarh-495678 for conducting B.Ed. course with an annual intake of 100 students vide order No. WRC/5-6/APW07842/723176/120th/2009/57240-57245 dt. 07.07.2009.

And whereas, after the promulgation of NCTE (Recognition, Norms and Procedure) Regulations, 2014 vide notification dt. 28.11.2014 the Kamla Nehru College, Run by Kamla Nehru Mahavidhyalaya Samiti, Rani Road, District-Korba, Chhattisgarh-495678 offering B.Ed. course was informed via email/public notice to submit a duly notarized affidavit as an acceptance of the NCTE Regulations, 2014 by the institution.

And whereas, after the receipt of affidavit dt. 28.01.2015 from the institution, a revised recognition order no. WRC/APW07842/723176/2015/140461 dt. 31.05.2015 was issued to the institution for conducting B.Ed. Programme of two years duration with an annual intake of 100 seats (two basic units of 50 students each) from session 2015-16.

And whereas, the letter no. 2197/Acad./2017 dt. 06.09.2017 received from the Registrar, Bilaspur University, Bilaspur, Chhattisgarh was placed before the WRC in its $281^{\rm st}$ Meeting held on $19^{\rm th}$ September, 2017 and the Committee decided as follows:-

"The Registrar, Bilaspur University, Bilaspur vide letter dt. 06.09.2017 has brought to the notice of the WRC that following institutions don't have Regular qualified Principal/Staff. The University has temporarily suspended the affiliation of these institutions and requested WRC to take further action in the matter as per NCTE Regulations, 2014.

The WRC decided to issue Show Cause Notice to the institutions."

And whereas, Show Cause Notice u/s 17(1) was issued to the institution on dt. 27.09.2017.

And whereas, the reply dt. 16.10.2017 of institution and a copy of letter no. 2477/Acad./2017 dt. 01.11.2017 from Registrar, Bilaspur University, Bilaspur was placed before the WRC in its 283^{rd} Meeting held on November 14^{th} – 15^{th} , 2017 and the Committee decided as follows:

"WRC noted the information received from the University. The University has also informed that the Kamla Nehru College, Run by Kamla Nehru Mahavidhyalaya Samiti, Rani Road, District-Korba, Chhattisgarh has still not appointed Principals till date.

Hence, Recognition of the college is withdrawn from the academic session 2018-2019."

Now, therefore, the recognition of Kamla Nehru College, Run by Kamla Nehru Mahavidhyalaya Samiti, Khasra No. 947/1, Rani Road, District-Korba, Chhattisgarh-495678 for conducting B.Ed. programme of two years duration with an annual intake of 100 seats (two basic units of 50 students), is hereby withdrawn-from-the-academic session-2018-2019 in terms of Section 17(1) of the NCTE Act, 1993.
