**RESTORATION ORDER**

WHEREAS, recognition was granted to the institution namely, **RAMTIRTH SHIKSHA & KALYAN SAMITIS, INDIRA GANDHI MAHAVIDYALAYA, MIG - 33, JAWAHAR CHOWK, BHOPAL** under section 15(3)(a) of NCTE Act, 1993 for conducting B.ED. course of one year duration with an annual intake of **100** students vide order No. WRC/5-6/44/2003/2007-13 dated 02.05.2003.

AND WHEREAS, WRC in its 92<sup>nd</sup> (II Sitting) meeting held on weft Dec 22<sup>nd</sup> to 24<sup>th</sup>, 2006 resolved to change the name of the institutions as **Teerath Institution** from the existing name **Ramtirth Shiksha & Kalyan Samiti, Indira Gandhi Mahavidyalaya, Bhopal, Madhya Pradesh** for B.Ed. Course vide order no. WRC/223087/2008/35099-101 dt. 27.05.2008. The revised recognition order was issued to **TEERATH INSTITUTE, DEEPDI, BHOJPUR ROAD, BHOPAL, CITY: BHOPAL, MADHYA PRADESH** vide order no. WRC/APW0574/223087/2015/144417-427 dt. 31.05.2015 for B.Ed. Programme of two years duration with an annual intake of 100 students (two units) from the academic session 2015-16.

AND WHEREAS, the institution has not submitted Compliance of revised recognition order dt. 31.05.2015.

AND WHEREAS, the matter was placed in 255<sup>th</sup> Meeting of WRC held on June 22<sup>nd</sup>-24<sup>th</sup>, 2016 and the Committee decided that "...The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not complied NCTE Regulations, 2014."

AND WHEREAS, a Show Cause Notice was issued to the institution on 27.07.2016 for not submitting the following documents in compliance of Regulation 2014 mentioned in the revised order:

- 1) Staff Profile for the session 2015-16 duly approved by the affiliating body.
- 2) Originally notarized CLU/NEC/BP and Building Completion Certificate.

AND WHEREAS, the reply of Show Cause Notice has submitted by the institution on dated 11.11.2016.

AND WHEREAS, the matter was placed in 310<sup>th</sup> Meeting of WRC held on 19<sup>th</sup> to 21<sup>st</sup> August 2019 and the Committee decided that:- "*The Show Cause Notice was issued to the institution vide letter dated 27/07/2016 and reply received on 11/11/2016. The summary of the case reveals that the reply was not submitted within the stipulated time of 30 days as per the Show Cause Notice. Moreover, the staff profile for approved intake not submitted in original. Principal is also not appointed. Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order.*"

AND WHEREAS, the Withdrawal order was issued to the institution on 05.09.2019.

AND WHEREAS, the Appellate Authority vide its order dated 02.03.2020 remanded back the case to the WRC, NCTE, for necessary action.

AND WHEREAS, the institution has submitted reply vide letter dt. 11.03.2020 received in WRO on 11.03.2020.

AND WHEREAS, the matter was placed in 316<sup>th</sup> Meeting of WRC held on 27<sup>th</sup>-28<sup>th</sup> August & 04<sup>th</sup> September, 2020 and the Committee decided that:- "*The WRC examined the documents submitted by the institution in response to the order of the Appellate Authority and observed that the*

**institution has complied with the requirements laid down under NCTE Regulations and decided that the recognition granted to the institution for B.Ed. course with an annual intake of 100 students (Two units) be restored from the date of issue of order.**

NOW THEREFORE, the recognition of **TEERATH INSTITUTE, DEEPDI, BHOJPUR ROAD, BHOPAL, CITY: BHOPAL, MADHYA PRADESH** is **Restored** from the date of this order for conducting B.Ed. course of two years duration with an annual intake of 100 students (Two units).
