WHEREAS in terms of Section 15 (1) of the NCTE Act, 1993 **CHHOTI DEVI MEMORIAL GIRLS B.ED. COLLEGE LADNUN ROAD, DIDWANA, NAGOUR, NAGOUR-341303, RAJASTHAN** submitted an application (Code No. APN03661) to the Northern Regional Committee of National Council for Teacher Education for grant of recognition / permission for starting ETE Course of 2 year duration with an annual intake of **50 students**.

2. AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith the Affidavit and the inputs received from the Visiting Team in the form of report and videography, the Committee is satisfied that the institution / society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the Secondary Teacher Education Education including the Norms and Standards for the Secondary Teacher Education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc for running the programme and has selected / appointed duly qualified teaching staff as per NCTE norms.
3. Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to **CHHOTI DEVI MEMORIAL GIRLS B.ED. COLLEGE LADNUN ROAD, DIDWANA, NAGOUR, NAGOUR-341303, RAJASTHAN** for conducting ETE course of 2 years duration with an annual intake of **50** students in the 1st year and the same for the 2nd year under clause 7 (12) of the NCTE Regulation dated 13th Jan 06 subject to fulfilment of the following :-
  - (i). The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account to be operated along with an official of the Regional Committee.
  - (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, as amended from time to time.
4. Further, the recognition is subject to fulfilment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc, wherever applicable.

5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the Statement of Annual Accounts duly audited by a Chartered Accountant.
6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act, 1993.
7. The institution shall maintain and update the Website as per provisions of NCTE Regulations.
