WHEREAS in terms of Section 14(1) of the NCTE Act, Smt. - 3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition Smt. Pani Devi Golechha BSTC School, Nakodaji Tirth Road, Himada, Jasol, Barmer, Rajasthan 344025 for conducting STC Course of two years duration with an annual intake of 50 (Fifty Only) students under clause 7(12) of Regulation dated 13.01.2006 subject to fulfillment of the following:
 - (i) The Institution shall within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Northern Regional Committee.
 - (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- Further, the recognition is subject to fulfillment of all such other requirements as may
 be prescribed by other regulatory bodies like UGC and the State Government etc, wherever
 applicable.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
- If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
