WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

AND WHEREAS, the institution i.e. Rana Pratap Physical Teacher Training College, Hinta Bhinder, Udaipur - 313603, Rajasthan has been recognized for B.P.Ed. by NRC vide order No. 18.08.2000 for an annual intake of 60 and further the seats were colleged to 100 vide order no. F.NRC/NCTE/F-3/ RJ-181/2000 dt. 20.09.2000.

AND WHEREAS, the institution Rana Pratap Physical Teacher Training College, Hinta Bhinder, Udaipur - 313603, Rajasthan has by affidavit consented to come under New Regulations and pagin for two basic units in B.P.Ed., which require additional facilities.

AND WHEREAS, it has been decided to permit the institution two basic units of 50 students each conditions namely.

The institution shall create additional facilities which include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds, (d) adherence to staff norms as per Regulations, 2014 and inform the Regional Committees with required documents by October 31, 2015.

The applicant Institution, for additional unit will be required to submit the required documents, such as land documents, Non-Encumbrance Certificate (NEC), Land Use Certificate (CLU) and of having Plan (BP) in the format available on the website, to the Regional Committee in proof BCC) may be given along with other documents, if available, otherwise it may be given to the Visiting Team at the time of inspection.

The Regional Committee shall arrange for verification of documents, inspection of the premises and check adherence to these conditions by 20 February, 2016. If it is found by the Regional permitted to admit students for the academic year 2016-2017.
