

6. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating SCERT / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.

7. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act, 1993.

**ORDER**

District Institute of Education and Training, Shahpura, Bhilwara, Rajasthan had submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition for 50 (Fifty) seats in B.S.T.C. course of two year duration in terms of Section 14(1) of the NCTE Act, 1993

2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following :-

- (a) The institution has the land for setting up the teacher education institution.
- (b) The institution has the building for conducting the course on the above mentioned land.
- (c) The institution has initiated the process for recruitment of Principal / Head of Department and teachers for the said course.

3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to District Institute of Education and Training, Shahpura, Bhilwara, Rajasthan for an intake of 50 (Fifty) seats in B.S.T.C. course of two year duration from the academic session 2003-2004 Subject to fulfillment of the following :-

- (a) Appointment of the Principal and faculty members duly qualified and staff as per the norms of NCTE / State Govt. / UGC is to be completed before the commencement of the session.
- (b) The countersigned statement of all faculty members from the Director of Elementary Education, Department of Education, Govt. of Rajasthan should be submitted before the commencement of the academic session 2003-2004.
- (c) Infrastructure and instructional facilities for the psychology lab be created.
- (d) The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- (e) Non-compliance of the above mentioned conditions shall cause action under section 17(1) of NCTE Act, 1993.

4. Recognition is subject to the condition that the affiliating body i.e. SCERT / State Govt. shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE / SCERT etc.

5. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like SCERT and State Government, etc.
