**ORDER**



AND WHEREAS the institution sought for permission for change of premises to **D.C.S. Teachers Training College, Village- Raghunathpura, Post office- Balawala, Diggi Road, Tehsil- Sanganer, District- Jaipur, Rajasthan-302029**, under clause 8 (9) of the NCTE Regulations, 2014.

AND WHEREAS the inspection of the institution was decided in the 238<sup>th</sup> meeting (Part-IV) and accordingly inspection of the New Premises was carried out by Visiting Team on 31.05.2015.

AND WHEREAS the Northern Regional Committee in its 239<sup>th</sup> meeting held from 30<sup>th</sup> June to 1<sup>st</sup> July, 2015 considered the file of the Institution alongwith VTR of the inspection carried out on 31.05.2015 and other related documents, NCTE Act, 1993, Regulations and permitted the shifting of the premises from Varun Path, Near Plice Station, Mansarovar, Jaipur to "**Village- Raghunathpura, Post office- Balawala, Diggi Road, Tehsil- Sanganer, District- Jaipur, Rajasthan-302029**."

NOW THEREFORE, the institution is allowed to shift its premises to **D.C.S. Teachers Training College, Village- Raghunathpura, Post office- Balawala, Diggi Road, Tehsil- Sanganer, District- Jaipur, Rajasthan-302029** under clause 8(9) of the NCTE Regulation 2014 to run B.Ed. Course of 2 years duration with annual intake of 100 seats of 2 basic units of 50 students each from the academic session 2015-16 subject to fulfilment of the conditions mentioned in the revised order No. F.No./NCTE/RJ-615/2015/117430-35 dated 22.06.2015 issued to institution by this office.


