Whereas, in terms of Section 14(1) of the NCTE Act, 1993, Gram Meduka Krishi Shikshan Samiti Meduka. And whereas, on scrutiny perusal of the application submitted by the institution, the documents attached therewith, the affidavit, and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee in its 251° meeting held on 30 April 102 May, 2016 is satisfied that the institution society fulfills the requirements under the provisions of NCTF Act. Rules and relevant Regulations including the Norms and Standards for the D.El.Ed. programme, such as, infrastructural and instructional facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected appointed duly qualified teaching staff as per NCTE norms.
