- b. Experience in legal work in various Courts, Government or regulatory authority, tribunals, Commissions or any other similar forum.
- c. Working knowledge of MS Office, Computer handling & Internet browsing.
- 4. Age Limit: Not more than 61 years as on the closing date of the Advertisement/Notice.
- 5. Remuneration: The selected candidates will be paid a consolidated amount of Rs. 40,000/- plus Rs. 5,000/- transport allowance per month.
- 6. Nature of Duties: The candidate so engaged as legal consultant is expected to work with the Legal Division of NCTE and shall perform various duties including following work:
 - a. Preparation of case summary;
 - b. Identification of legal issues for adjudication;
 - c. Legal appreciation of other laws/Acts that have bearing on the case;
 - d. Legal research for precedents of Hon'ble Supreme Court, High Courts and judgments of various Commissions;
 - e. Preparing counters for writ petitions etc.;
 - f. Preparing draft Order and any other legal work as assigned.

7. Terms & Conditions:

- a. The legal consultant on having accepted the offer of engagement shall enter into a contract, with the National Council for Teacher Education, detailing the terms and conditions of engagement, also with a confidentiality clause before being assigned any work.
- b. Any breach of such Contract by the legal consultant shall be considered a sufficient ground for the termination of the engagement made under the Contract and may result in debarring such legal consultant from future engagement and making him/her also liable for an action as deemed fit by the Commission.
- c. The engagement may be terminated at any time by the NCTE by giving a notice of fifteen days. Similarly, if a candidate wants to resign he/she has to give fifteen days' notice in advance.
- 8. Undertaking: The successful candidates would be required to abide by detailed terms and conditions of engagement given in the attached Annexure-II and conditions mentioned in Para 6 above.
- 9. Method of Selection: The selection of candidate will be made as per order/guidelines on the subject. The candidates will be shortlisted based on marks in Law degree examination from a recognized University, and experience in the requisite field. TERMS AND CONDITIONS OF ENGAGEMENT

- 1. The appointment of Legal Consultant would be on full time basis and they would not be permitted to take up any other assignment during the period of consultancy with the NCTE.
- 2. The Consultant shall not indulge in or disclose to any person, any details of office, operation process, technical know-how and administrative/organizational matters which is of confidential/secret nature.
- 3. The Consultant shall be required to maintain discipline and absolute integrity in accordance with the rules as contained under the CCS (Conduct) Rules, 1964.
- 4. The appointment of Consultant is of a temporary (non-official) nature and the appointment can be cancelled at any time.
- 5. The post is based in New Delhi. The Consultant shall not be entitled to any allowance such as Dearness Allowance, Residential Telephone, Transport Facility, Residential Accommodation, Personal Staff, CGHS, Medical Reimbursement etc.
- 6. Consultant shall be eligible for 10 days leave in a calendar year on prorate basis. Therefore, a Consultant shall now draw any remuneration in case of his/her absence beyond 10 days in a year (calculated on a prorate basis). Also, un-availed leave in a calendar year cannot be carried forward to next calendar year.
- 7. The NCTE would be free to terminate the services in case of unauthorized absence of consultant for more than 15 days beyond the entitled leave in a calendar year without compelling reasons.
- 8. No TA/DA shall be admissible for joining the assignment or on its completion.
- 9. The NCTE shall not be liable for any loss, damage, theft, burglary or robbery of any personal belonging/equipment or vehicles.
- 10. The Consultant shall not claim any benefit/compensation/absorption/regularization of service with this office under the provisions of Industrial Disputes Act, 1947 or Contract Labour (Regulation & Abolition) Act, 1970.
- 11. The Consultant may be called on Saturday, Sunday and other gazette holidays, if required for which he shall not be paid any remuneration/honorarium. However, this will be adjusted against absence period. He should claim the adjustment within two months of attending the office on Saturday, Sunday and other gazette holidays.
