

VACANCY CIRCULAR

Subject: Engagement of Consultant for Liaison work for construction of NCTE Building at Dwarka, New Delhi

The National Council for Teacher Education (NCTE), a Statutory Body under the Ministry of Human Resource Development, New Delhi, is constructing its own building at Dwarka, New Delhi through the Central Public Works Department, New Delhi. The NCTE intends to engage a Consultant on contract basis to be called Liaisoning Officer to monitor the progress of physical construction of NCTE Building who will liaise with the departments, such as, CPWD, DDA, Delhi Fire Service, DUAC and other concerned agencies who may be associated with the project of construction of NCTE building. He will also be associated with other allied works relating to the commissioning of the building.

2. The person concerned should have Post Graduate Diploma in Management/Master in Business Administration with specialization in Marketing/Human Resource with at least IInd Division/50% marks and experience of at least 5 years of liaisoning work in a Govt organization of repute. The selected person will be paid consolidated remuneration of Rs. 35,000/- per month and in addition, conveyance allowance of Rs. 5,000/- p.m. with no other allowances. He will be working on full-time basis as per rules of NCTE. He will be engaged for a period of six months or until further orders.
