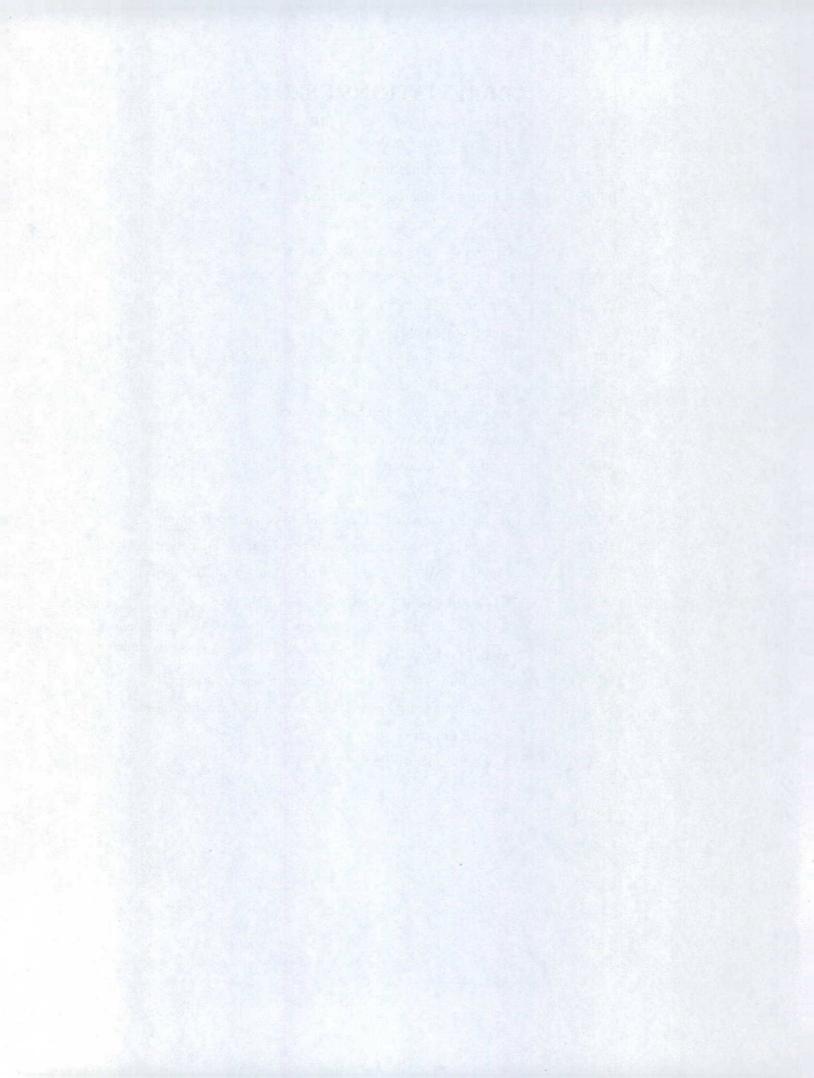

#### Chapter 1

# **NCTE:** An Introduction

The national Council for Teacher Education (NCTE), a statutory body established by an Act of Parliament (Act No. 73 of 1993), started functioning on 17<sup>th</sup> August, 1995 with its Head Office in New Delhi with a mandate to achieve planned and co-ordinated development of the teacher education through-out the country; for regulation and proper maintenance of norms and standards in the teacher education system and for matters connected therewith. Besides eminent educationists, Education Secretary of the HRD Ministry, Education Secretaries of State Governments, Members of Parliament, Heads of National Educational Institutions like NCERT, NIEPA, UGC the Council comprises three full time members, namely, Chairperson, Vice-Chairperson and Member Secretary who are appointed by the Government of India. They are vested with executive powers and as such are responsible for implementing the NCTE Act, Rules and Regulations made thereunder and also the policy decisions of the Council taken from time to time.

In accordance with the NCTE Act, 1993, four Regional Committees look after matters related to Teacher Education in different regions, namely, East, West, North and South. The offices of Regional Committees are presently located at Bhubaneswar, Bhopal, Jaipur and Bengaluru. Each Regional committee comprises a Chairperson, some eminent educationists and Administrators and Education Secretaries of the State Governments/UTs located in the region. The Regional Director, a full time officer of the NCTE, functions as Executive Head of the Regional office as well as Convener of the Regional Committee. The Regional Committees are specially empowered to implement Sections 14, 15 and 17 of the NCTE Act, in accordance with the Regulations, Norms and Standards framed from time to time for different programmes of Teacher Education. The Regional Committees receive and process applications for new institutions and applications for additional programmes / intake in the existing recognized institutions under Section 14 and 15 of the NCTE Act respectively. The Regional Committees have the powers to withdraw recognition of a recognized Institution under Section 17 of the NCTE Act provided it is established that the concerned institution has contravened provisions of the NCTE Act or Rules and Regulations under which recognition/permission has been granted to them.

In NCTE Headquarters work is distributed among the sections namely Academic Section deals with academic matters including development of Curriculum Frameworks for different Teacher Education Programmes, Publication of Journals, Books and Monographs on important themes of education, organization of lectures, etc., the Regulations Section collects and examines feedback regarding the implementation of the Regulations in vogue and coordinates the development of new regulations, as and when required, the inspection Section conducts inspection of recognized Teacher Education Institutions under Section 13 of the NCTE Act. After causing the

inspection, the VT reports are analyzed by a group of experts to draw conclusion and formulate recommendations for communicating to the concerned institutions, the institutions aggrieved by the decisions of a Regional Committee under Section 14, 15 or 17 of the NCTE Act are provided an opportunity to file an Appeal with the Council under Section 18 of the NCTE Act. So the Appeal Section functions as the Secretariat for the Appellate Authority constituted by the Council. After examining the appeals, the Appeal Committee recommends the action deemed appropriate in the matter, the Legal Section keeps track of the cases filed against the NCTE in the Hon'ble Supreme Court of India and various High Courts and Coordinates with the NCTE's Counsels, the EDP Section manages the NCTE's website to have a functional online linkage of Regional Committees with the NCTE Hqs., system of application processing in public domain and linking of websites of all teacher education institutions to the Website of NCTE.

#### Chapter 2

#### Major Developments and Achievements

NCTE undertakes several activities to implement its mandate every year. Some of the activities undertaken during previous years are in continuation of the activates initiated and completed during the preceding years and some new activities are also undertaken in response to the new demands emanating from the emerging imperatives and priorities in the field. The present chapter presents a broad overview of the activities and programmes undertaken by the Council during 2017-2018 in furtherance of its goals and objectives.

#### (a) NCTE Mandate and Programmes

#### (i) NCTE Act

The National Council for Teacher Education (NCTE) was established by an Act of Parliament (No. 73 of 1993) with a mandate to achieve planned and coordinated development of teacher education throughout the country, for regulation and proper maintenance of norms and standards in the teacher education system, and for matters connected therewith. The NCTE came into existence on 17<sup>th</sup> August, 1995. Its headquarters in Delhi, with 4 Regional Committees in Bhubaneswar, Jaipur, Bhopal and Bengaluru.

#### (ii) Functions

NCTE is mandated to carry out the following functions:

- Coordinate and monitor teacher education and its development in the country.
- Lay down norms for any specified category of courses or trainings in teacher education, including the minimum eligibility criteria for admission thereof; and the method of selection of candidates, duration of the course, course contents and mode of curriculum.
- Lay down guidelines for compliance by recognized institutions, for starting new courses or training, and for providing physical and instructional facilities, staffing pattern and staff qualification.
- Lay down standards in respect of examinations leading to teacher education qualifications,
   criteria for admission to such examinations and schemes of courses or training programmes.
- Lay down guidelines regarding tuition fees and other fees chargeable by recognized institutions.
- Examine and review periodically the implementation of the norms, guidelines and standards laid down by the Council, and to suitably advise the recognized institution.
- Make recommendations to the Central and State Governments, Universities, University
  Grants Commission and recognized institutions in the matter of preparation of suitable plans
  and programmes in the field of teacher education.
- Formulate schemes for various levels of teacher education and identify recognized institutions and set up new institutions for teacher development programmes.
- Undertake surveys and studies relating to various aspects of teacher education and publish the
  results thereof.

- Take all necessary steps to prevent commercialization of teacher education.
- Evolve suitable performance appraisal system, norms and mechanism for enforcing accountability on recognized institution.
- Lay down guidelines in respect of minimum qualifications for a person to be employed as a teacher in schools or in recognized institutions.
- Promote and conduct innovation and research in various areas of teacher education and disseminate the results thereof.
- Perform such other functions as may be entrusted to it by the Central Government.

#### (iii) Regional Committees: Territorial Jurisdiction

The applications for establishing a Teacher Education Institution or a Teacher Education Programme are submitted to and evaluated for recognition by the 4 Regional Committees of NCTE which cover the following States/UTs under their jurisdiction.

- Eastern Regional Committee, Bhubaneswar: Arunachal Pradesh, Assam, Bihar, Jharkhand, Manipur, Meghalaya, Mizoram, Nagaland, Odisha, Sikkim, Tripura, West Bengal. (N=12)
- Western Regional Committee, Bhopal: Goa, Gujarat, Madaya Pradesh, Maharashtra, Dadra and Nagar Haveli, Daman & Diu, Chhattisgarh. (N=7)
- Northern Regional Committee, Jaipur: Haryana, Himachal Pradesh, Punjab, Rajasthan, Uttar Pradesh, Chandigarh, Delhi, Uttrakhand. (N=8)
- Southern Regional Committee, Bengaluru: Andhra Pradesh, Karnataka, Kerala, Tamil Nadu, Lakshadweep, Andaman & Nicobar Islands, Pondicherry, Telangana. (N=8)

# Academic

NCTE as the nodal agency taken up project on the National Teacher Platform (NTP) named, DIKSHA launched by the MHRD. The project will enable accelerate and amplify many solutions in the realm of teacher education. DIKSHA platform will provide high quality learning content and an environment for collaboration for teachers across the country for their continuous professional growth.

- 2. For fostering a culture of quality within TEIs, following steps have been taken:
- (a). An earmarked fund is being created for capacity building of teacher educators and NCTE staff.
- (b). Model curriculum for all 15 teacher education programmes are being prepared along with a curriculum for the mandatory 20 weeks internship programme.
- (c). Preparing B.Ed. Integrated with specialization (4 years) Academic focus is shifting towards visualizing and environment having only an integrated B.Ed. Programme, with built in specialization catering to pre-primary, primary, secondary, etc. areas of teacher education.

#### Appeal

In terms of the provisions of section 18 of the NCTE Act, persons aggrieved by the orders issued by the Regional Committee under section 14, 15 and 17 can prefer appeals in the prescribed form to the Council within 60 days of issue of such orders along with the prescribed fee and with the memorandum of appeal. On receipt of memorandum of appeal, the Council calls for the records of the case from the concerned Regional Committee and after giving the appellant a reasonable opportunity of being heard, passes such orders as it may deem fit. The Council endeavors to dispose of every appeal within a period of 3 months from the date of its filling.

During the period from 1<sup>st</sup> April, 2017 to 31<sup>st</sup> March, 2018, the Appeal Committee held 19 Meetings and total numbers of 999 appeals were heard, considered and out of these, 715 cases were disposed of/order issued.

#### **Inspection Division**

Section 13 of the NCTE Act, 1993 provides for inspection of recognized Teacher Education Institutions for the purposes of ascertaining whether the recognized institutions are functioning in accordance with the provisions of the Act and Rules and Regulations made thereunder. After conducting inspection of TEI in the manner prescribed under rules, the Council has to communicate its view to the concerned institution in regard to the results of the inspection and after ascertaining its opinion recommends action to be taken by the Regional Committee concerned.

During 2017-18, the NCTE conducted inspection of 75 TEIs in the State of Bihar in compliance to the section 13 of the NCTE Act 1993.

To monitor the functioning of recognized TEIs from time to time and to grant recognition to new TEIs/Programmes the NCTE has to cause inspection with the help of experts for which the Council maintains a Panel of VT experts in the form of database. Empanelment of experts is a continuous process and the panel is updated regularly. Efforts are being made to empanel experts of considerable experience in the academic field through a transparent process.

#### Mandatory Affidavit System (MAS)

All Teacher Education Institutions who did not submit the mandatory documents like Affidavit or reply of Show Cause Notice in the year 2016-17 were directed to submit Mandatory Affidavit along with additional information. TEIs who submitted the Affidavit or reply of Show Cause Notice were also directed to update their complete data on the TeachR portal designed and developed by Quality Council of India (QCI). The Mandatory Affidavit System (MAS) through TeachR portal was opened with a time frame of 17.06.2017 to 12.09.2017 against which 17319 TEIs got registered out of which 6900 TEIs filled and completed the data along with requisite fees fixed by the NCTE. However, this matter is sub-judice in the court until further orders.

#### General Administration

(i) Digitization of Records:- E-office has been implemented wherein all the records of NCTE Hqrs. and its Regional Committees have been digitized and uploaded on the Server for faster accessibility and transparency. Further, all correspondences are being made by the NCTE-HQrs and RCs in digital form. This has also reduced the consumption of paper significantly.

- (ii) Government E-Market Place (GEM):- The NCTE has been enrolled on the Government E-Market Place Portal for procurement of goods and services in a time and cost-effective manner.
- (iii) Central Public Procurement Portal:- The NCTE has also been registered with Central Public Procurement Portal whereby all the tenders/bids for various purposes are being hosted on this portal through e-publishing system.
- (iv) NCTE Building at Dwarka: The 85000 Sq. ft. Ground + Four Story building at Dwarka has been constructed by CPWD and handed over to NCTE. As per the decision of the Council in its 46<sup>th</sup> Meeting held on 28<sup>th</sup> March, 2017 to relocate all the four Regional Committee Offices to the NCTE newly constructed building at Dwarka. The Northern, Regional Committee has shifted to Dwarka Building and the rest of the Regional Committees are in the process of shifting.
- (v) Yoga Day:- The NCTE Hqrs. organized the 3<sup>rd</sup> International Yoga Day at their office premises on 21<sup>st</sup> June, 2017. All the employees of NCTE Hqrs have participated in large number to perform the Yoga Asanas under the guidance of Yoga Instructor. Similarly, all the four Regional Committees also organized the Yoga Day in their offices and asked the TEIs of their jurisdiction to organize the Yoga Day in their respective premises.

#### E-governance (EDP)

NCTE is moving towards implementation of E-Governance system in all its functions assigned through the NCTE Act, Rules & Regulations to achieve its objective of planned and coordinated development of Teacher Education. E-Office has been implemented in the NCTE Headquarters and its four Regional Committees Offices. NCTE has also registered on the Government E-Market place and the Central Public Procurement Portal from timely and cost-effective procurement of goods and services (EDP Section has helped the GA of NCTE in achieving that).

- 1. Regular maintenance and updating in the NCTE portal from time to time and as per the recuirement from different sections.
- 2. Maintenance of data of TEIs through GIS.
- 3. Selection of VT member's modules through online VT module with the help of current vendor.
- 4. Appeal process with the help of online appeal module through the current vendor.
- 5. RTI module with the help of online RTI module through the current vendor.
- 6. Grievance module with the help of online Grievance module through the current vendor.

### **Establishment**

- i) Swaschta Pakhwada The Swaschtha Pakhwada was organized by NCTE in its premises in the first fortnight of September, 2017. All the employees participated in the event and lot of unwanted records and items were removed and premises was cleaned.
- ii) Blood Donation Camp A Blood Donation Camp was organized in the NCTE Hqrs Offices on 29<sup>th</sup> January, 2018. A team of Indian Red Cross Society (IRCS) collected blood from a number of employees who were found fit for blood donation. A letter of appreciation has also been given by IRCS to NCTE for organizing this noble event.
- iii) Shifting of Regional Committees of NCTE to New Delhi The General Body of NCTE in its 46<sup>th</sup> meeting held on 28<sup>th</sup> March, 2017 had taken a decision for shifting of four Regional Offices of NCTE to newly constructed building at Dwarka, New Delhi.

### Vigilance Awareness Week

Vigilance Awareness week 2017 was celebrated at NCTE, Hqs., New Delhi from 30<sup>th</sup> October 2017 to 4<sup>th</sup> November 2017 and all Regional Offices of NCTE with the theme "My Vision-Corruption Free India".

With a view to create awareness, the banners were displayed at prominent places with public interface at NCTE office. The pledge ceremony was held on 31<sup>st</sup> October, 2017 in the NCTE, Hqs., 69 officers/officials attended the pledge ceremony.

On the occasion message of honesty and ethical conduct was conveyed to the staff present. The staff was made aware about the menace of corruption and its consequences on the development at individual, societal and national level.

#### Co-ordination

### 1. General body meeting of the NCTE Council

47<sup>th</sup> meeting of the General Body of NCTE was held on 28<sup>th</sup> March 2018 at Conference Hall, INSA – 2 Bεhadur Shah Zafar Marg, New Delhi. The minutes of the meeting have been drawn up and uploaded on the website of NCTE.

# Chapter 3

# STATUS OF NCTE RECOGNIZED TEACHER EDUCATION PROGRAMMES – REGION AND STATE-WISE

#### 1. Introduction

As explained in Chapter 1, the NCTE Act, 1993 had envisaged establishment of four Regional Committees to process the applications of Teacher Education Institutions intending to offer a Teacher Education Programme. On the basis of detailed examination of the application and assessment of the applicant's fitness and preparedness, the Regional Committee takes a decision to either grant or refuse recognition for the proposed programme. The status of the recognized Teacher Education Programme during 2017-2018 is briefly described below:
