ORDER

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993, **Magadh University, Bodh Gaya, Dist.- Gaya, Bihar-824234** has applied for grant of recognition for **B.Ed. Course (Code No. APE00536)** was received by Eastern Regional Committee of NCTE on 23.08.2005.

2. **AND WHEREAS**, the University was granted recognition for conducting B.Ed. course vide Order No. ERC/7-75.6(I).8/2007/7916 dated 03.05.2007 with an intake of 100 (One hundred) by the ERC, NCTE, followed by revised order issued vide No. 32446 dated 30.05.2015 as per NCTE Regulations, 2014.

3. **AND WHEREAS**, as per decision of 244th ERC Meeting, recognition granted to B.Ed. course was withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session vide ERC Order No. ER-244.17.11/APE00536/B.Ed./2017 /54742 dated 18.10.2017.

4. **AND WHEREAS**, the University preferred an appeal to NCTE HQs. and the Appellate Authority vide Order No. 89-772/E-53486/4th Mtg.-2018/3rd & 4th April/65641 dated 26.04.2018 decided to set aside the impugned refusal order dated 18.10.2017. Appellant institution is required to submit to ERC copies of the faculty list submitted by it in December, 2013 as well as in November, 2016 within 15 days of the issue of appeal orders.

5. **AND WHEREAS**, the ERC in its 256th Meeting held on 30th - 31st May, 2018 re-viewed the matter in accordance with the appeal order as well as letter dated 27.04.2018 received from the University on 01.05.2018, together with copy of faculty list submitted by it in December, 2013 and in November, 2016.

In view of the above, the Committee decided as under:

Recognition for B.Ed. Course is continued.

6. **NOW THEREFORE**, the recognition granted to B.Ed. Course issued vide order no. ERC/7-75.6(I).8/2007/7916 dated 03.05.2007 is **hereby continued** till further orders.
