## **ORDER**

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993, Vikramaditya College of Education, Plot No. 2009, Vill-Arawan, Khedubigha, Po-Aat, Tehshil/Taluka- Wen, Town/City-Bihar Sharif, Dist-Nalanda, Bihar-803114 had submitted an application (Code No.ERCAPP1013) to the Eastern Regional Committee of NCTE for grant of recognition for conducting B.Ed Course with an annual intake of 100 (one hundred) by online on (mm/dd/yyyy) 9/24/2011 and hard copy of application submitted on (mm/dd/yyyy) 9/27/2011.

WHEREAS, as per the decision of ERC in its 157 meeting held on 27-29 June 2013, recognition order was issued to Vikramaditya College of Education, Plot No. 2009, Vill-Arawan, Khedubigha, Po-Aat, Tehshil/Taluka- Wen, Town/City-Bihar Sharif, Dist-Nalanda, Bihar-803114 for conducting B.Ed. Course of Secondary (level) of one year duration with an annual intake of 100 (one hundred) from the academic session 2014-2015 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009, vide ERC order No. ERC/7-157.6.21/NCTE/B.Ed./2013/19450 dated 09-Jul-13.
- 3. AND WHEREAS the applicant institution/trust/society filed a writ petition (C) No. 458/2013 in the Hon'ble Supreme Court of India against the said recognition order dated 09-Jul-13 issued by ERC, NCTE and the Hon'ble Supreme Court disposed of the writ petition with a direction that recognition granted by the NCTE to the institution will apply for the academic session 2013-2014.
- 4. AND WHEREAS the Eastern Regional Committee in its 160 Meeting held on 26-27-Aug-2013 considered the original file of the institution along with the order of the Hon'ble Supreme Court dated 18-Jun-13 and decided that revised recognition order from the session 2013-2014 may be issued to the institution instead of the session 2014-2015.
- 5. - 6. The recognition is subject to fulfillment of the following:
