- Tullion fee and other fees will be charged from the students as per the norms of the affiliating university/State Government till such time NOTE regulations in respect of fee structure come into force
- Curriculum transaction, including practical work/activities, should be organised as per the norms and stantlards for the course and the requirements of the affiliating university/examining body.
- Teaching days including practice teaching should not be less than the number fixed in the NCTE corns for the course.
- The Institution shall switch over to Two-year course from the academic session 2004-2005

The institution shall continue to fulfill the norms laid down under the regulations of the NCTE and submit to the Regional Committee the Annual Report by 31st March and the Performance Approximal Report within 45 days of the last examination/academic sossion every your.
