NOW, THEREFORE, in exercise of the powers vested under Section (4(3)) (a) of the NCTE Act, 1993, the Eastern Regional Committee hereby grants recognition to Ursuline Primary Teachers' Education College, Chandrapura, Po Maheshpur Raj, Dist Pakur, Jharkhand 816106 for conducting E.T.E. (Diploma in Education) Course of two years duration with an annual intake of 50 (fifty) students under clause 7(10) of Regulation dated 13-1-2006 subject to fulfillment of the following:
  - (i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Eastern Regional Committee.
  - (ii) The institution shall comply with the various other norms and standards prescribed in the NÇTE regulations, as amended from time to time.

- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like Central Government/ State Government etc, wherever applicable.
- 5. The institution shall submit the Eastern Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff.
- 6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules Regulations and Orders made or issued thereunder, the Eastern Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
