ORDER

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993, **Rajeev Gandhi Memorial Teacher's Training College, 12-Digwadih, P.O.– Pathardih, Dist.– Dhanbad, Jharkhand – 828119** has applied for grant of recognition for **B.Ed. Course (Code No. APE00858)** was received by Eastern Regional Committee of NCTE on 11.09.2007.

2. **AND WHEREAS**, as per decision of 93rd ERC Meeting, formal recognition order was issued vide no. ERC/7-93.6(II).14/2009/15784 dated 23.03.2009 with an intake 100 from the academic session 2009-2010 to the institution, followed by revised order issued on 31/05/2015 as per Regulation, 2014.

3. **AND WHEREAS**, as per decision of 244th ERC Meeting held on 8th – 9th October 2017, recognition granted to B.Ed. course was withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session vide Order No. ER-244.17.5/APE00858/B.Ed./2017/54713 dated 18/10/2017.

4. **AND WHEREAS**, the institution preferred an appeal to NCTE HQs. and the Appellate Authority vide Order No. 89-710/E-46249/2017-Appeal/2nd Mtg.-2018/3rd & 5th Feb., 2018/64055 dated 16/03/2018 remanded back the case to ERC with a direction to re-examine the matter and take further action as per the NCTE Regulations, 2014. In the meanwhile, the order of withdrawal shall be kept in abeyance.

5. **AND WHEREAS**, the ERC in its 254th Meeting held on 16th – 17th April, 2018 reviewed the matter in accordance with the appeal order and observed that all required documents, as submitted by the institution to the Appellate Authority, have been received.

In view of the above, the Committee decided as under:


Recognition for B.Ed. Course is continued.
