**ORDER**

In exercise of the authority vested under NCTE Act, the Eastern Regional Committee after considering the application of **Bibhuti Bhusan Govt. P.T.T.I., Ghatbour, Bongaon, North 24-Parganas (West Bengal)** for grant of recognition to the **Primary Teachers' Training Course** of one year duration, has decided to extend provisional recognition for one year with effect from the academic year 2000-2001 with intake of **40 (forty)** students subject to removal of the following deficiencies :

- (i) Three teachers besides Principal with the Qualifications prescribed by NCTE should be in position.
- (ii) Laboratory & Library should be enriched as per NCTE norm.
- (iii) Supervised practice teaching should be arranged as per NCTE norm.
- (iv) Subscription to the Journals should be augmented as per NCTE norm.
- (v) Instructional area should be as per NCTE norm.
- (vi) The Institution should have women's hostel.

The institution can apply for higher intake if more teachers are qualified as per NCTE norms are appointed in the Institution.

The institution concerned is advised to send a compliance report about removal of above deficiencies to the Eastern Regional Committee by 31.8.2000.
