Order

In supersession of the order No.ERC/7-43(ER-43.6.1)/2004/1127(7) dated April 8, 2004 issued to The Assembly of God Church Teachers' Training Junior College, Buntain Education Centre, 125/ 1, Park Street, Kolkata, West Bengal, Pin-700 017, the following order is issued to the said institution for grant of recognition of TTC course from the academic session 2004-2005.

In terms of Section 14(1) of the NCTE Act, 1993 The Assembly of God Church Teachers' Training Junior College, Buntain Education Centre, 125/ 1, Park Street, Kolkata, West Bengal, Pin- 700 017 had submitted an application to the Eastern Regional Committee of NCTE for grant of recognition for starting TTC Course of two years duration from the academic session 2004-2005.

2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:

- i) The institution has possessed the land and building, for setting up the teacher education institution, on long term lease basis for 40 years commencing from 01.11.1973.
- ii) The institution has created an Endowment Fund of Rs.5.00 lakhs and Reserve Fund is yet to be created.
- iii) The institution has selected the Principal and 08 (eight) teachers for the said course and the list of faculty members has also been approved by the affiliating body i.e. Deptt. of School Education, Govt. of West Bengal.

3. Now, therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, and taking into consideration the availability of necessary infrastructure and faculty members in the institution and request of the Principal, the Regional Committee hereby amends its earlier order dated April 8, 2004 and grants recognition to **The Assembly of God Church Teachers' Training Junior College, Buntain Education Centre, 125/ 1, Park Street, Kolkata, West Bengal, Pin-700 017 for TTC Course of two years duration from the academic session 2004-2005 with an annual intake of 50 (fifty) students subject to fulfillment of the following:**

- a) That the institution will ensure that Principal/ Head and at least 05 (five) faculty members duly approved by the affiliating body are in position for an intake of 50 (fifty) students before commencement of the course and a report to this effect shall be sent to the Eastern Regional Committee within one month of commencement of the course.
- b) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Eastern Regional Committee.


- c) The institution shall send confirmation within one month from the commencement of the academic session that teachers are paid State Govt./ UGC scale.
- d) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government etc.

5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating body to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.

6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.


