<u>ORDER</u>

AND WHEREAS the applicant institution/trust/society filed a writ petition (C) No. 306/13 in the Hon'ble Supreme Court of India against the said recognition/permission order dated 17-Apr-13 issued by ERC, NCTE and the Hon'ble Supreme Court disposed of the writ petition with a direction that recognition/permission granted by the NCTE to the institution will apply for the academic session 2013-2014.

AND WHEREAS the Eastern Regional Committee in its 158 Meeting held on 23-24 July 2013 considered the original file of the institution along with the order of the Hon'ble Supreme Court dated 26-Jun-13 and decided that revised recognition/permission order from the session 2013-2014 may be issued to the institution instead of the session 2014-2015.
